HOUSE

Friday, February 22, 1929.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mrs. Knowlton of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Bill an act to increase the salary of the County Treasurer of Franklin county, H. P. 1057, H. D. 329, which was passed to be engrossed in the House, February 15th.

Comes from the Senate passed to be engrossed as amended by Senate Amendment A in non-concurrence. In the House:

(Senate Amendment A read by the Clerk.)

The House voted to reconsider its action whereby this bill was passed to be engrossed and further voted to adopt Senate Amendment A in concurrence, and the bill was passed to be engrossed as amended by Senate Amendment A in concurrence.

Senate Bills in First Reading S. P. 147, S. D. 182: An act relating to the Portland Terminal Company.

S. P. 148, S. D. 183: An act to ssolve the Somerset Railway dissolve the Company andthe Washington County Railway Company.

In the Senate, read and passed. In the House, read and passed in concurrence.

From the Senate: The following Order:

Whereas the State of Maine for a period of approximately twenty years has pursued the policy of retaining within its territoral limits the hydro-electric energy produced by water powers within its borders, and

Whereas this policy has been challenged on economic grounds by parties interested in the ownership of water powers and water power sites within the State, and

Whereas a proper settlement of the problem of a desirable water power policy should be predicated solely upon the question of what policy is for the best interests of a majority of our own people

Ordered, the House concurring, that the committee to which has referred Senate Document been No 44 and other bills and orders dealing with the subject matter of the export of hydro-electric energy is hereby requested and directed to conduct such an investigation into the economic phases of the problem of power export as in the opinion of said committee and its members may be necessary to advise this Legislature, at the time of making its report on said bills or orders or any one of them upon the following matters:

industrial (1) The price of power as sold by public utility corporations in Maine, in New Hampshire and in Massachusetts. (2) The trend of such prices in

said states during a period of not less than the last three years.

The probable cost of con-(3)struction of a power transmission line from the probable terminus in Maine to the probable terminus in Massachusetts with a designation of those probable termini.

(4) The probable cost of operation of such a line including capital charges and transmission losses.

(5) The relative cost of power developed in Maine delivered to points in Maine, in New Hampshire and in Massachusetts.

(6) The probable effect of the construction and operation of such a line upon the price of industrial power in Maine, in New Hampshire and in Massachusetts.

The present ratio of steam (7)installation to hydro installation of the major utilities in Maine, in New Hampshire and in Massachusetts.

The desirable ratio of such (8) installations, having regard to the nature of the loads of the several utilities.

(9) The present freight costs for goods being manufactured in substantial quantities in Maine, in New Hampshire and in Massachusetts with a comparison of the same between state and state.

(10) The trend of freight costs during a period of not less than the last three years with information if any is available of prospective changes.

(11) The proportion of power cost and freight costs in the present major industries in said states, exclusive of such of those industries as depend upon raw materials available in large quantities in the state of manufacture.

(12) The relative worth to the owners of powers and power sites in Maine of such powers or sites used, first, in manufacture and second, for the production of hydroelectric energy for sale.

(13) The minimum amount of power export necessary to make the construction and operation of a transmission line to Massachusetts commercially feasible.

(14) The class or kind of power, as now in use in New Hampshire and in Massachusetts, which power exported from Maine will probably replace and, if more than one class or kind, the proportion or amount of the several classes, that is, prime, secondary and relay.

(15) The desirability, from a capital standpoint, having regard to power cost, to freight cost, and to other items, of the location of industry in Maine under present conditions and after the construction of a line capable of transmitting electric energy in large amounts to New Hampshire and to Massachusetts.

Comes from the Senate read and passed as amended by Senate Amendment "A" as follows:

Amend Senate Document No. 155 by striking out paragraphs num-bered three and four on the second page, paragraphs numbered twelve and thirteen on the third page, and paragraph numbered fourteen on the third and fourth pages of the printed document; by striking out the words "hydro installation" in the paragraph numbered seven on said third page and inserting in blace thereof the words 'average daily demand'; by striking out the word "costs" in the paragraphs numbered nine and ten on said third page and inserting in place thereof the word 'rates'; by striking out the words "said states" 'n

the second line and "of manufacture" in the fourth line of the paragraph numbered eleven on said page and inserting in place of the words "said states" the word 'Maine'; and by renumbering paragraphs five, six, seven, eight, nine, ten, eleven and fifteen respectively, three, four, five, seven, eight, nine, and ten.

Orders of the Day

The SPEAKER: The Chair presents the first matter today assigned, being the report of the committee of Education ought to pass on H. P. 290, H. D. 87, an act to provide for the support of the University of Maine, tabled by the member from Norridgewock, Mrs. Folsom, earlier in the morning, and the Chair recognizes the member.

Mrs. FOLSOM: Mr. Speaker and members of the House: House Paper 290, House Document 87, an act to provide for the support of the University of Maine, substitutes for the present method of maintaining and supporting the University of Maine a mill tax. The committee on Education had a public hearing Wednesday on this bill. The President of the University, several of the trustees, and many alumni and friends of the University were present, and all manifested a desire that this bill should pass.

The University of Maine has probably had in the past for its support-the average has probably been a mill. Last year, for the of the maintenance and support University of Maine, we gave seveneighths of a mill. This year the trustees are asking for one and eighths of a mill. one-eighth mills. If this bill passes, the trustees will not again have to come before the committee on Education or before the Legislature asking for maintenance. It will relieve them of that duty and they can begin then some program of expansion and growth which will cover a number of years, knowing that the funds necessary for that expansion and growth will be forthcoming. The sum would be a definite sum varying only as the valuation of the State varies. The committee unanimously reported ought to pass on this bill, and I move that the committee's report ought to pass on act to provide for the support of the University of Maine be accepted.

The SPEAKER: The member from Norridgewock, Mrs. Folsom, moves the acceptance of the committee's report ought to pass. Is the House ready for the question?

A viva voce vote being taken the motion to accept the committee's report, ought to pass, prevailed; and on further motion by the same member the rules were suspended and the bill given its two several readings and tomorrow assigned.

The SPEAKER: There being no further business under Orders of the Day the Chair will make the following statement relative to the status of legislative business at the close of the eighth legislative week.

On Tuesday, February 12, there were pending in the various combills. On Tuesday. mittees 929 February 19, there were pending in the committees 953 bills or 24 more than there were the week preceding. Ninety bills went into the committees during the week and only 56 reports came out; that is to say that the committee have not yet reached the point of being able to dispose of bills as fast as they are referred. This is somewhat disappointing, as it seemed reasonable to hope that the peak load in committees was reached last week. Of the measures now in committees some 300 are special road resolves which will not have to be reported out separately and there are other appropriation resolves which will not have to be separately reported. Even making allowance for these measures, however, there still re-mains to be reported from the committees a great volume of legislation, much of which will go through to enactment, and therefore through the House routine of the several readings. It seems likely that the majority of the bills now in committee are either routine in character or relatively non-controversial and that the consideration and report thereof should not unduly burden the committees. The Chair urges that the committees do their utmost to get in their reports during the six remaining days of the current month, so as to leave the month of March as free as possible for the major problems of the session which will doubtless require debate With respect to bills of the most controversial character the Chair will suggest that when an agreement in committee and a consequent unanimous report is obviously impossible, alternative reports be brought into the House promptly for the acceptance of the one or the other instead of holding bills in committee for a more prolonged discussion when the chance of ultimate agreement is negligible.

Beginning on Tuesday, March 5th, Tuesday sessions will probably be at 10 o'clock in the forenoon. It is suggested that committees make plans to use Tuesday afternoons from March 5th on either for hearings or executive sessions. Later in March there will be sessions in all probability at four o'clock on Monday afternoons, but those sessions will probably not be held on the first Mondays in March when many of the members desire to attend the town meetings.
