S. P. 46, S. D. 26: An act relating to the appointment of trustees of Normal Schools

Mr. LOCKE of Biddeford: Speaker, I would like to ask the indulgence of this House and the Speaker for a few minutes reference to this bill. We been legislating here for the last seven or eight weeks for the purpose of protecting fish, protecting bears. protecting muskrats and porcupines, but this bill, Mr. Speaker, and members of the House, is very misleading in its title. The title of this bill should be changed to "An Open Season on Democrats". (Laughter) I ask you to read the bill, please, and bear with me for a few moments. Senate l'aper 46, Senate Document 26. I do not believe that it is a part of the Republican program of this Legislature to stoop so low as to attempt by legislative enactment to prevent the possibility of Democrats holding office as trustees of your normal schools. I do not believe the honorable Senator Aroostook, when this bill was presented, gave any thought to that matter. I am charitable enough to say that she presented it unthinkingly, without any particular thought. Now I want you to read it, and if you will bear with me I will read it for you:
"Be it enacted by the People of

the State of Maine as follows:

Section 1. Section one hundred forty-four of chapter sixteen of the revised statutes is amended by striking out in the third and fourth lines thereof, the words: 'and not more than two shall be of the same political party, so that said section as amended shall read as follows:

'Sect. 144. Said schools shall be under the direction of a board of five trustees, four of whom shall be appointed by the Governor with the advice and consent of Council, for terms of four years. The State Superintendent of Public Schools is, by virtue of his of-fice, a member of the said board of normal school trustees. Said board shall have charge of the general interests of said schools." And the rest of it as the act is now.

The situation, Mr. Speaker, and Members of the Assembly, is just this: I had occasion this morning to trace these amendments down and from 1905 up to the present period of twenty-four time, a years, this law has not been necessary. In 1905 it was changed from a board of seven members to a board of five-four members and the State Superintendent of Public Schools, which this bill provides for, but the legislators, in their

wisdom, thought that some time there might be some political subterfuge that would create havoc with our normal school system and they very wisely provided that not more than two members shall be appointed from any one political party and that is the way it is now. I do not know whether they are Democrats or Republicans on the board, but I do know, Members of the House, that if you pass this act, it will not be possible for a member of the minority party to become a member of that board. It does not say so in the act, but that is probably the intent of the act. I assure you I do not think that the Senator from Aroostook put this in and unthinkingly turning the grindstone unknowingly for somebody. No, as I said, I do not believe it is the principle of this Republican organization here to allow anything like that to go through this House, and I thin you fair minded men and women. think

Although we are in a minority, we have worked happily here since the convening of this legislature, and I hope that this happy concord may continue until such time as the legislature may adjourn. Let us keep the normal schools where they are. I do not think they are going to put four Republicans on or four Democrats. It it were Democratic organization in control of this House and this thing presented itself, I would raise my voice against it because I do not believe in that principle of organization. I fully realize that as a majority party you have the power to pass any legislation that you see fit; but this, members of the House, is not worthy, to my mind, of the smallest ward-heeler in any particular ward. particular ward in the State of Maine or in the city of Chicago. I ask you now, then, to allow the minority party to at least have some representation upon vour board of trustees of your normal schools, which if this act is passed to be enacted, it will not have. do not ask you as Republicans nor as Democrats. I have not asked one man in this House to support this measure. I am going to leave it to you to your fair minds, and, Mr. Speaker, I move that this matter be indefinitely postponed.

Mr. KITCHEN of Presque Isle:

Mr. Speaker, I move that Senate Paper 46, Senate Document 26, lie on the table.

The SPEAKER: Does the gentleman name a date for assignment? Mr. KITCHEN: Next Wednesday, Mr. Speaker.

Mr. Boynton: Mr. Speaker, I wish to present House Amendment A to H. P. 336.

The SPEAKER: The attention of the Chair is called to the fact that the pending question is the acceptance of the report. Does the gentleman move that the report be accepted so that the bill may be brought into an amendable stage?

 \bar{Mr} . BOYNTON: Yes, Mr. Speaker.

Thereupon, on motion by Mr. Boynton of South Portland the report was accepted, and on further motion by the same gentleman, it being a printed bill, the rules were suspended and the bill given its first two readings.

The SPEAKER: The gentleman from South Portland (Mr. Boynton) now offers House Amendment A to H. P. 336, which the Clerk will read.

House Amendment A to H. P. 336, entitled an act regulating the catching of smelts in the waters of Casco Bay and mouth of the Presumpscot River in Cumberland County.

Amend said bill by striking out in the second, third and fourth lines thereof the words "and the mouth of the Presumpscot River adjacent to the city of Portland and the town of Falmouth in Cumberland county."

A viva voce vote being taken the amendment was adopted and tomorrow assigned for third reading.

The SPEAKER: Is there any further business under orders of the day?

On motion by Mr. Littlefield of Farmingdale the House voted to reconsider its action whereby it specially assigned for Tuesday March 5th S. P. 48, S. D. 28, resolve in favor of the Bangor State Hospital for maintenance; and on further motion by the same gentleman this bill was taken from the table.

On motion by the same gentleman the bill was passed to be engrossed.

On motion by Mr. Varnum of Westbrook the House voted to reconsider its action whereby S. P. 304, S. D. 112, an act additional to Chapter 242 of the Private and Special Laws of 1895, entitled an act to incorporate the city of

South Portland was tabled and specially assigned for Thursday, March 7th.

Mr. VARNUM: Mr. Speaker, I yield the floor to the member from Portland, Miss Laughlin,

Miss LAUGHLIN: Mr. Speaker, I move that this bill be now given its third reading. I think that is the pending motion.

The SPEAKER: The member from Portland Miss Laughlin, now moves that the bill be taken from the table and further moves that the bill be given its third reading.

Thereupon the bill was taken from the table and had its third reading.

Mr. STURGIS of Auburn: Mr. Speaker, I move that this bill be retabled.

A viva voce vote being taken, the motion failed of passage, and the bill was passed to be engrossed.

Mr. BISSETT of Portland: Mr. Speaker, I want to ask the House to reconsider its vote on House Paper 336 which was assigned for its third reading tomorrow morning, and have the bill and amendment lie on the table.

The SPEAKER: Can the gentleman inform the Chair to what the bill relates.

Mr. BISSETT: Smelts in the Presumpscot River. I move that the bill and amendment lie on the table.

The SPEAKER: The present status of the measure is that it was asigned for third reading tomorrow morning, at which time the gentleman may, if he desires, offer an amendment. Does the gentleman still desire the bill to lie upon the table?

Mr. BISSETT: Yes sir.

Thereupon the House voted to reconsider its action whereby it assigned for third reading tomorrow morning H. P. 336, H. D. 99; and on further motion by the same gentleman, a viva voce vote being taken, the bill was tabled pending assignment for third reading.

The SPEAKER: Is there any further business under orders of the day?

Mr. FARRIS of Augusta: Mr. Speaker, referring to H. P. 1470, bill an act relating to Workmen's Compensation, I move that we recon-

sider the vote whereby we ordered

The SPEAKER: The gentleman refers to H. P. 1470 presented by the gentleman from Naples, Mr. Bove, appearing on page five of the printed calendar; and the gentle-man moves that the House re-consider its action whereby it voted to print five hundred copies of this bill.

The motion to reconsider prevailed, and on further motion by the same gentleman one thousand copies were ordered printed.
