Thursday, March 7, 1929.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Porter of

Gardiner.

Journal of the previous session read and approved.

Mr. HOLMAN of Farmington: Mr. Speaker, I wish to present the following resolution, out of order, and move its adoption.

The SPEAKER: The gentleman Farmington, Mr. Holman, from asks leave to present out of order a resolution and moves its adoption.

The Clerk will read the resolution.

RESOLVED that in the untimely death of Bert H. Farrington, who died at Jay, March 5th, 1929, the town of his adoption, his county and the State at large has met with an irreparable loss;

RESOLVED that the House instruct the Clerk to send his wife

the following telegram:

'The House of the Eighty-fourth Legislature extends to you and your children its sympathy in this great hour of grief."

RESOLVED that a committee of seven be appointed to represent the House at the funeral of our deceased member, that the same be appointed by the Speaker, of which committee he shall be a member.

The resolution was adopted by a unanimous rising vote.

Mr. CHASE of Cape Elizabeth: Mr. Speaker, my friendship with the late member from Jay, Mr. Farrington, was based upon our association in this and in the last Legislature. It is easy for me to understand the faith and confidence which his fellow townsmen placed in him. Firm in purpose and strong in his convictions, yet, withal, modest and unassuming, he soon won the respect and admiration of his associates. He never would cherish animosity or countenance unfair methods. He was honorable and reliable and always diligent in his duty. It is indeed with few and simple words that I take my leave of our late friend. May his spirit of courage and fairness animate all of us in the work which lies before us.

Thereupon the Speaker appointed as the committee to attend the funeral Representatives Wing of Kingfield, Blanchard of Phillips, Gillespie of Meddybemps, Crawford of Houlton, Campbell of Leeds and Wright of Bath.

Mr. KITCHEN: Mr. Speaker and members of the House: In connection with the ceremony this morning I can think of nothing more appropriate than these few lines by John White Chadwick, entitled "Auld Lang Syne," which I will read:
