HOUSE

Wednesday, March 13, 1929.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Dunnack of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Report of the Committee on Sea and Shore Fisheries, reporting ought not to pass on bill an act relating to suspen-sion or revocation of lobster li-cense, S. P. 67, S. D. 37. Comes from the Senate, report

read and accepted.

In the House:

Mr. ROUNDS of Portland: Mr. Speaker, this is one of the most drastic bills that will ever be introduced into the Legislature. It is a bill which provides if a poor fisherman goes out to sea and catches lobsters, somebody who is getting a good salary wakes up with a big head in the morning and tells him that his license is sus-He is the complainant, he pended. is the attorney, and he is the judge. It leaves it so that all they can do is to go to the Supreme Court, and you can tell how long-he has ten days to do it in-and you can tell how long it would take to get it through the Supreme Court.

Now I want to read this bill, which is a short bill:

"Be it enacted by the People of the State of Maine, as follows:

R. S. c. 45, sec. 20; 1919, c. 184, 1921 c. 98 is hereby amended by striking out the words: 'The direc-tor of sea and shore fisheries in his discretion may, before conviction, suspend the license of any person, firm or corporation whenever he has evidence that such person has violated any of the laws relating to lobsters. Upon the suspension of license all traps, wars, gear, and all devices used in connection with catching lobsters shall be taken from the water within five days after suspension. Any person with traps, cars or any other device remaining in the water, after the expiration of the five days, shall be fined five dollars per day for each trap, car or other device remaining in the water, and any car, smack,

vehicle or other device used in holding, carrying or transporting lobsters by any person whose license has been revoked or suspended shall be forfeited and become the property of the state; so that said section shall read as follows:

"If any person, firm or corpora-tion, their servants or agents, licensed as provided in this chapter, shall be adjudged guilty of violation of any law relating to lobsters, the director of sea and shore fisheries may revoke the license of such person, firm or corporation so adjudged guilty and upon such revovation all rights under the license so revoked shall cease, and no such person, firm or corporation so adjudged guilty shall be entitled of right to receive a license for the period of one year, and the license shall be suspended from the date of complaint or indictment until the final determination by the court.

You can see before a man is convicted he has lost his livelihood.

(At this point the Messenger of the House escorted to a seat to the left of the Speaker the Honorable Clarence Hale, Judge of the United District Court and the States Speaker's father, amid the applause of the House, the members rising.)

Mr. ROUNDS continuing: There is no place, not even in Mexico, where they shoot them right down, where they do not give them a mock trial, if nothing more. But here this man can revoke the license of any man who is trying to do business and deprive him of his livelihood. Therefore I think the bill ought to be substituted for the report, and I move that the bill be substituted for the report.

The gentleman The SPEAKER: from Portland, Mr. Rounds, moves that the bill, Senate Paper 67, Senate Document 37, an act relating to suspension or revocation of lobster license, be substituted for the ought not to pass report. Is the House ready for the question?

Mr. SINCLAIR of Rockland: Mr. Speaker, as a member of the committee to which this bill was referred, I have some explanation I would like to make of the matter. This bill has been the law since 1919, and lobster fishermen. as I understand, nearly all lobster fishermen, do not object to the law. Some lobster fishermen, who have been caught with short lobsters and have lost their licenses, come before the Legislature and want the law repealed or amended. The Director of Sea and Shore Fisheries tells the committee he cannot enforce the law unless he has those provisions. I therefore hope that the motion of the gentleman from Portland (Mr. Rounds) does not prevail.

Mr. ROUNDS: Mr. Speaker, this is all right in a certain way, but whoever heard of a man being convicted before a trial? If that is the law of the United States, I should like to know it. I think the worst criminal has a right to be heard in court, therefore I think it right that no man should be arbitrarily deprived of his license.

Now I want to cite one case in York county, not in Cumberland, but in York county. Here a man comes around, and because he answers him back, he is one of the most, I will say the most, saucy men he ever heard of because he answers him back. Now that man gets his livelihood from fishing, and his license will be suspended, but it is right that every man have a trial in court. Therefore I hope that the motion I made will prevail.

The SPEAKER: Is the House ready for the question? The pending question is on the motion of the gentleman from Portland, Mr. Rounds, that the bill, Senate Paper 67, Senate Document 37, an act relating to suspension or revocation of lobster license, be substituted for the ought not to pass report. As many as are in favor of the gentleman's motion will say aye; as many as are opposed will say no.

A viva voce vote being taken, the motion prevailed; and on further motion by the gentleman from Portland, Mr. Rounds, the bill received its first two readings and tomorrow assigned.

Should such committee determine that it is necessary for it to hold a hearing in order to carry out the purpose of its appointment, it shall have the power to summon witnesses, and the secretary of the Senate is directed to issue subpoenas for such witnesses as the committee may require.

Comes from the Senate, read and passed.

Mr. KITCHEN of Presque Isle: Mr. Speaker, in regard to this matter, I have been informed that yesterday morning a resolve was introduced into the Senate addressing a message to the Governor. What became of that I do not know. This morning there has come from that body this order, and it seems to me that hasty action here would be ill-advised. I move that the order lie upon the table.

The SPEAKER: Does the gentleman incorporate in his motion a motion for the printing of the order?

Mr. KITCHEN: Yes, Mr. Speaker.

The SPEAKER: This motion to table is not debatable. As many as are in favor of the motion will say aye; as many as are opposed will say no.

A viva voce vote being taken, the motion to table prevailed.

Mr. JACK of Lisbon Falls: Mr. Speaker, should we not know how long that should lie on the table.

Mr. JACOBS: That was a question, Mr. Speaker, I wished to ask.

The SPEAKER: The gentleman from Lisbon Falls (Mr. Jack) may, if he desires make some motion with reference to the assignment of the order.

Mr. JACK: I move, Mr. Speaker, that it be assigned for tomorrow morning.

Mr. KITCHEN: That is perfectly agreeable to me, Mr. Speaker.

The SPEAKER: The gentleman from Lisbon Falls, Mr. Jack, moves that the order be specially assigned for consideration tomorrow morning. Is this the pleasure of the House?

Mr. ALDRICH of Topsham: Mr. Speaker, I assume that this order has been laid upon the table for the purpose of enabling the members

of this House to become familiar with its contents. The order will not be printed so that we will have it in our hands, I suppose, before tomorrow morning. Therefore, I should like to amend the gentleman's motion and ask that it be assigned for Friday morning that we may have an opportunity to look it over.

Mr. JACK: That is agreeable to me, Mr. Speaker,

The SPEAKER: Does the gentleman from Lisbon Falls, Mr. Jack, ask leave to amend his motion by substituting Friday morning for Thursday morning?

Mr. JACK: Yes, Mr. Speaker. Thereupon, Mr. Jack was given permission by the House to so amend his motion, and the motion as so amended received passage.

The SPEAKER: The committee on Ways and Bridges was the suggestion of the committee on Reference of Bills.

Mr. ALDICH: I move you, Mr. Speaker, that the matter be referred to the committee on Ways and Bridges.

Thereupon, the bill was so referred.

The SPEAKER: The Chair presents the second matter today assigned, bill an act relating to the salary of the Register of Probate for Oxford County, H. P. 1611, H. D. 621, tabled on March 8 by the gentleman from Porter, Mr. Stanley, the pending question being third reading, and the Chair recognizes the gentleman.

Thereupon, on motion by Mr. Stanley, a viva voce vote being taken, the bill was retabled, pending third reading.

The SPEAKER: The Chair presents the third matter today assigned, House report—Legislation Inexpedient—from the committee on Interior Waters on bill an act relating to the pollution of the waters of Carleton Pond, H. P. 15, tabled on March 8 by the gentleman from Augusta, Mr. Farris, the pending question being acceptance of report, and the Chair recognizes the gentleman.

Thereupon, on motion by Mr. Farris, the bill was recommitted to

The SPEAKER: The Chair presents the first unassigned matter, H. P. 1211, H. D. 403, bill an act for the regulation and control of outdoor advertising, which was referred to the committee on Judiciary in the House on February 19th, comes from the Senate, referred to the committees on Judiciary and Maine Publicity jointly in non-concurrence, the bill having been tabled on March 6th by the gentleman from Van Buren, Mr. Hammond, the pending question being motion by the gentleman from Augusta, Mr. Williamson, that the House recede and concur, and the Chair recognizes the gentleman from Van Buren, Mr. Hammond.

Mr. HAMMOND: Mr. Speaker, this is an act which involves a legal question with an incidental taxation matter, and it should properly be referred to the committee on Judiciary, and I think that is where it belongs. I now hope that the motion of the gentleman from Augusta, Mr. Williamson, will not prevall.

Mr. WILLIAMSON of Augusta: Mr. Speaker and Members of the House: This bill was introduced on February 19th and today is March 13th, and the bill has not yet gone to a committee. The Senate saw fit to add the Publicity Committee to tho Judiciary Committee and make a joint reference. It does not seem to me that at this time we should question the action of the Senate. It is much more important that business be expedited and that this matter be given a full and fair hearing. I fear that if the matter is longer delayed, that at the end of the session it will not receive the consideration which otherwise the measure would receive. I therefore urge the members to support the motion to recede and concur with the Senate in a joint reference of this matter.

The SPEAKER: Is the House ready for the question? The question is on the motion of the gentleman from Augusta, Mr. Williamson, that the House recede and concur with the Senate in the reference of this bill to the two committees on Judiciary and Maine Publicity. As many as are in favor of the motion will say aye: as many as are opposed will say no.

A viva voce vote being taken, the motion prevailed, and the bill was so referred.

The SPEAKER: The Chair presents the second unassigned matter, H. P. 1512, H. D. 614, bill an act relating to the registration of nurses, tabled on March 6 by the gentleman from Lewiston, Mr. Rodolphe Hamel, the pending question being third reading.

Mr HAMEL: Mr. Speaker, I have no further objection to this measure and I now move that it receive its third reading at this time.

Thereupon the bill received its third reading and was passed to be engrossed.

The SPEAKER: The gentleman from Presque Isle, Mr. Kitchen, yields to the gentleman from Calais, Mr. Eaton.

Mr. EATON: Mr. Speaker, I move this bill, Senate Paper 368, be passed to be enacted.
