Tuesday, March 19, 1929.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Walch of Yarmouth.

The SPEAKER: This being an emergency measure, it is necessary under the Constitution that it have the affirmative vote of two-thirds the entire membership of this body. As many as are in favor of the final passage of this resolve will rise and stand in their places until counted and the monitors will return the count.

A division being had,

One hundred and thirty voting in the affirmative and none in the negative, the resolve was finally passed.

Orders of the Day

The SPEAKER: Under Orders of the Day the Chair presents the first matter tabled and today assigned, majority report ought to pass and the minority report ought not to pass from the committee on Salaries and Fees on S. P. 65, S. D. 36, bill An act relating to fees of sheriffs and their deputies, tabled by the gentleman from Poland, Mr. McKnight, on March 13th, the pend ing question being acceptance of either report, and the Chair recognizes the gentleman.

Mr. McKNIGHT: Mr. Speaker and Ladies and Gentlemen of the Eighty-fourth Legislature: In support of my position that I took on this bill, and of the committee, in bringing in the minority report, I wish to say to the House at this particular time that I do not wish to cumber up the calendar, and I am willing to hurry things along as fast as I can, but I would like to have this bill retabled.

I would say that I have taken this bill up with all the deputy sheriffs in the House I know of, the ex-deputy sheriffs,—and also have taken the matter up with the Attorney General, and have talked with one or two other lawyers in regard to this matter. There seems to be a divided opinion; and having gone through with a bill similar to this two years ago in regard to deputy sheriffs, which was found to be not entirely satisfactory, I ask the indulgence of the House, and move this bill be retabled.

Thereupon, the motion prevailed and the bill was retabled pending acceptance of either report.

The SPEAKER: The Chair presents the second matter today assigned, House report ought not to pass from the committee on Legal Affairs, H. P. 858, H. D. 282, bill an act in relation to athletic exhibitions, creating a commission prescribing its powers and duties, providing penalties for violations of the provisions thereof and repealing sections of an act therein named, tabled on March 14th by the gentleman from Franklin, Mr. Blaisdell, the pending question being motion of the gentleman from Westbrook, Mr. Robie, that the bill be substituted for the report, and the Chair recognizes the gentleman from Franklin, Mr. Blaisdell. Mr. BLAISDELL: Mr. Speaker,

I yield the floor at this time to the gentleman from Westbrook, Mr. Robie.

Mr. ROBIE: Mr. Speaker, at the

present time we have on our statute books laws that permit the holding of boxing bouts. This bill was presented by a gentleman from Portland, and is a copy of the laws in effect in some other states. It was my opinion that this bill, when presented, would correct several evils that are existent now in our present statutes. For this reason, when the report came back from the committee on Legal Affairs, ought not to pass, it was my intention to recommit the bill to the committee and have it redrafted, to correct these errors. It developed over the week-end that I had a chance to talk with the man who was the real proponent of this bill, and after having talked with him, he was quite willing to have the bill withdrawn, or the report of the committee accepted, for the reason the fundamental principles of the thing may be all right, but the bill was so full of legal errors and the time so short, he was willing to have it withdrawn instead of trying to correct them at this time. Therefore, Mr. Speaker, I ask leave to withdraw my motion for the substitution of the bill for the report.

The SPEAKER: The gentleman from Westbrook, Mr. Robie, asks leave of the House to withdraw his motion for the substitution of the bill for the report. Is there any objection to such withdrawal? The Chair hears none and the gentleman is allowed to withdraw his motion.

On motion by Mr. Robie, the ought not to pass report of the committee was accepted.

The SPEAKER: The Chair presents the third matter today assigned, (H. P. 1622) (H. D. 640) bill an act relating to county jails, tabled on March 15th by the gentleman from Belfast, Mr. Taylor, the pending question being motion of the gentleman from Guilford, Mr. Heath, for indefinite postponement, and the Chair recognizes the gentleman from Belfast, Mr. Taylor.

Mr. TAYLOR: Mr. Speaker, I yield to the gentleman from Guilford, Mr. Heath.

Mr. HEATH: Mr. Speaker, I would like to ask permission to withdraw my motion.

The SPEAKER: The gentleman from Guilford, Mr. Heath, asks leave of the House to withdraw his motion for indefinite postponement. Is there objection on the part of the House to the gentleman so doing? The Chair hears no objection, and the gentleman's motion is withdrawn.

On motion by Mr. Heath, the bill received its second reading and tomorrow assigned.

The SPEAKER: The Chair presents the fourth matter today assigned, joint order relative to joint rules, tabled yesterday afternoon by the gentleman from Cape Elizabeth, Mr. Chase, the pending question being passage in concurrence, and the Chair recognizes the gentleman.

Mr. CHASE: Mr. Speaker, I offer House Amendment A and move its adoption.

House Amendment A to Joint Order relative to Joint Rules.

Amend said order by striking out in the fourth line the word "involving," and inserting in place thereof the word 'carrying.'

Mr. FOSTER of Ellsworth: Mr. Speaker, in defense of the Appropriations Committee, on this order, the way it is drawn, I want to say just a word. Now we do not mind the substitution of the word "carrying" for the word "involving," but I would like to take you back to the Legislatures of 1923, 1925, and 1927. You will find on the back page of the little handbook this order, or suggestion, rather: "No act or resolve involving any appropriation can be engrossed unless it bears the following endorsement: Examined and recorded by the committee on Appropriations and Financial Affairs." I am rather surprised that the gentleman from Cape Flizabeth, (Mr. Chase) had not discovered that word "involving" before this.

Now it has been whispered around by certain members that the Appropriations Committee are trying to grab something for That is absolutely unthemselves. true and without foundation. We find, if we do not get these bills tabulated, we are pretty likely to get into serious trouble.

I will cite you just one instance of the last Legislature: The porcupine bill was passed here, but there was no appropriation set off against it for the reason that it got

by us somewhere; it never came to our committee. Now that meant that the payment of the porcupine bounty had to be taken out by the Governor and Council from the contingent fund. Had we had that bill listed, we would have been able to set off an appropriation against it, and eliminated all that trouble.

Now, gentlemen, we do not want any more trouble than we have now. Certainly we have enough work to do, and if any member of this House feels we haven't, I would like to take him up in our committee and go over with tim the report for 1925 and 1927, with which I am familiar. I think you will agree with me, it is some job. Now I do not want to take up any more of your time, but I hope this is made perfectly plain to you.

The SPEAKER: Is the House ready for the question? The question is on the adoption of House Amendment A to the joint order. As many as are in favor of the adoption will say aye; as many as are opposed will say no.

A viva voce vote being taken, the amendment was adopted; and on further motion by Mr. (base, the joint order as amended by House Amendment A, received passage.

The SPEAKER: Is there any further business under Orders of the Day?

There are twenty-two matters on the table unassigned.

On motion by Mr. McKnight of Poland, it was voted to take from the table the seventeenth unassigned matter, House report ought to pass in new draft, committee on Ways and Bridges, on bill an act relative to highways through towns of less than five thousand inhabitants, H. P. 522, H. D. 151, new draft H. P. 1645, H. D. 672, tabled by that gentleman on March 15th, the pending question being acceptance of report. Mr. McKNIGHT: Mr. Speaker, I now yield the floor to the gentleman from Standish, Mr. Hawkes.

Mr. HAWKES: Mr. Speaker, the objection to this bill was taken care of in the new draft, House Paper 1645, House Document 672. I therefore move the acceptance of the report.

Thereupon, on motion by Mr. Hawkes, House Report, ought to pass in new draft, was accepted; and on turther motion by the same gentleman, this being a printed bill, the rules were suspended, and the bill had its two several readings at this time and tomorrow assigned.

The SPEAKER: Is there any other matter which may be taken from the calendar?

Mr. KITCHEN of Presque Isle: Mr. Speaker, I would just like to call the attention of the members to the number of unassigned inatters on the calendar today, and while it would not be my wish to unnecessarily hurry any of the members, I should like very much, and am very sure it would expedite matters, if there were any further matters unassigned today which could be taken off at this time. I simply bring this matter to your a tention. There might be some matters as well taken care of now as later.

The SPEAKER: Is there any other of the unassigned matters which any member will take from the table? There appear to be more unaters on the calendar tabled and unassigned than at any previous time in the session. There apparently being none, the Cierk will read the notices.

On motion by Mr. Ward of Limestone,
