Monday, March 13, 1933.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Pressey of

Augusta.

Journal of the previous session read and approved.

The SPEAKER: The Chair has felt, up to a few days ago, that it might be possible for this session of the Legislature to adjourn finally by March 18th. Within the last week of course we have received and must act upon matters affecting taxation of intangibles, excise tax on electric power, coming in under the initiative provisions of the Constitution. We have had several bills having to do with the set-up of the convention to ratify the Eighteenth Amendment. One more is to be introduced tonight. We have had matters connected with the banking situation which have taken a lot of our time. The Chair has conferred with the President of the Senate and the chairmen of the various committees, and feels that if we all work toward that end that we should adjourn, providing nothing more comes in to bother us, by the 24th of March, which will be a week from next Friday. If we could do that, it would be the earliest adjournment of the Legislature since 1903, which in and of itself is worth striving for. Therefore let us all strive to get through the 24th of March if we can, not at the sacrifice, of course, of careful consideration of any measure that may be
