#### HOUSE

#### Tuesday, March 14, 1933

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Howes of Hallowell.

Journal of the previous session read and approved.

From the Senate: Bill an act providing for the calling of conventions for adoption or rejection of proposed Amendments to the Constitution of the United States, submitted by Congress to Conventions, (H. P. 1594), which in the House yesterday was received by unanimous consent under suspension of the rules, and referred to the committee on Federal Relations.

Comes from the Senate, referred to the Eighty-seventh Legislature in non-concurrence.

In the House:

The SPEAKER: The reason for the action taken by the Senate on this bill is as follows: The three previous bills that have been introduced in the House having to do with the set-up of the machinery for Constitutional Conventions to act upon the repeal of the Eighteenth Amendment have all pertained to that particular amendment and have been received by unanimous consent on the theory that it was necessary to act on them at this time. This particular bill sets up machinery to act on Constitutional Amendments generally without reference to the particular ones now before us.

Is it now the pleasure of the House to recede and concur with the Senate in the reference of this bill to the Eighty-seventh Legislature in concurrence?

Thereupon the House voted to recede and concur with the Senate.

wonder if the members of the House have any idea of how much these pension bills are going to cost the State, and who they are going to benefit? I have before me here Legislative Document Number 897. Perhaps you are all familiar with these bills. I will not read the name. "... in very feeble health; her mother's brother was a Civil War veteran . . . his army record is on stances, and has no relative to as-sist her. She has been a hard working woman, and is deserving of assistance."

Now we have appropriated one hundred and eighty dollars a year for this woman. I claim that there

are hundreds of other women in this State who are just as much entitled to a pension as this party. I am only speaking on this particular party. If you will refer to your Legislative Documents 902 and 901, you will find the same thing, where people are getting pensions, being sons and daughters of veterans. We set up \$65,000 for these pensions, thinking that would be sufficient to take care of them. It will run very much more. These bills are laid on the table until we can get some idea of how much it is going to cost us to take care of them. We are simply going wild on pensions and other a passage, and you can do with it what you wish.

Thereupon, the resolve was finally passed.

House Amendment B to House Paper 1170, Legislative Document 561, bill an act relating to reports to towns of excise tax payments.

Amend said bill by striking out all after the enacting clause and substituting in place thereof the following:

"The State Controller shall report

semi-annually as of June thirtieth and December thirty-first to each town and city in the State showing the excise tax payments on automobiles paid to that town or city, receipts for which have been filed with the Secretary of State."

Thereupon, House Amendment B was adopted.

that House Amendment A and ac-Companying bill lie on the table. The motion is not debatable. Mr. FLANDERS: Mr. Speaker, I would like to have this amendment

read.

Thereupon, the amendment was read by the Clerk. The SPEAKER: The gentleman from Northport, Mr. Hills, has moved that this matter lie on the table. All those in favor will say aye; contrary minded, no. A viva voce vote being taken, the

motion failed of passage.

TheThe SPEAKER: pending question is on the motion to adopt House Amendment A.

Mr. HILLS: Mr. Speaker, my idea of tabling was simply that quite a few of us thought four dollars a day was enough, and this called for \$4.50.

Mr. FLANDERS: Mr. Speaker and ladies and gentlemen: I think that I have worked for economy in the Legislature as much as anywhen this body, and matter of salaries for the deputy sheriffs was brought up, I could not see why we should cut our deputies twenty per cent when we are only cutting our sheriffs and the other officers ten per cent. Now these men, as you know, are in a hazardous position, and you know they are on call twenty-four hours a day, and, as the amendment shows, they shall not receive any fee for services rendered except \$4.50 a day and seven cents a mile instead of ten cents a mile. I hope this amendment will receive a passage.

Mr. HOBBS of Hope: Mr. Speaker, I think Mr. Flanders' ideas are inconsistent with his ideas of cutting the jurors. He gives them a cut of thirty per cent. Why not give the deputies the same cut as you do the jurors?

Miss LAUGHLIN of Portland: Mr. Speaker, it seems to me this is an entirely different situation from that of the jurors. That is an incidental employment; the matter of the deputy sheriffs is a three hundred and sixty-five days a year employment and service, and for the work they are doing they are not over-paid at the present time, and to cut them ten per cent, in view of the salary being only five dollars a day, it seems to me is all this Legislature ought to do. I trust this amendment will be adopted.

The SPEAKER: The pending question is the adoption of House Amendment A, offered by the gen-tleman from Auburn, Mr. Flanders. All those in favor will say aye; contrary minded, no.

A viva voce vote being taken, House Amendment A was adopted, and under suspension of the rules, the bill as amended by House Amendment A received its third reading and was passed to be engrossed.
