#### SENATE

Thursday, January 12, 1933.

Senate called to order by the President.

Prayer by Rev. A. W. Brown of Gardiner

Journal of yesterday read and approved.

Papers from the House disposed of in concurrence.

The following bills and resolve were received and on recommendation by the committee on reference of bills were referred to the following committees:

#### Labor

Mr. Holmes of Androscoggin: An Act relating to the pauperizing of unemployed wage earners. (S. P. 42.)

Mr. Holmes of Androscoggin: An Act to prevent the maintaining of a black list in industry. (S. P. 43.)

(500 copies of each ordered printed.)

Sent down for concurrence.

#### Legal Affairs

Mr. Hathaway of Piscataquis: An Act to extend charter of Hinckley Development Company. (S. P. 47.) Sent down for concurrence.

#### State Lands and Forest Preservation

Mr. Viles of Kennebec: Resolve naming that portion of Township 3, Range 9, W. E. L. S., Piscataquis County, 5,960 acres, donated to the State by Percival Proctor Baxter, "Baxter State Park." (S. P. 46.) Sent down for concurrence.

#### **Orders**

On motion by Mr. Kitchen of Aroostook, it was

Ordered, the House concurring. that when the Senate and House adjourn, they adjourn to meet Tuesday, January 17, at 4.30 o'clock in the afternoon. (S. P. 44.)

Sent down for concurrence.

Subsequently the foregoing order came back from the House read and passed in concurrence.

On motion by Mr. Kitchen of

Aroostook, it was Ordered, that the use of the Senate Chamber be accorded to the Maine Sportsmen's Fish and Game Association for the afternoon of Friday, January 27, 1933.

On motion by Mr. Viles of Kennebec, it was

Ordered, the House concurring, that three hundred and fifty copies of the Legislative Record for the session of 1933 be printed and bound, one copy each for the members of the Senate, House of Representatives, Secretary of the Senate and Clerk of the House and the remainder to be deposited in the State Library for exchange and library use; and be it further

Ordered, that three hundred and fifty copies of the Legislative Record be printed in pamphlet form for distribution from day to day to members of the Legislature and the departments, under the direction of the Document Clerk, and be it further

Ordered, that a suitable index be prepared for such Legislative Record under the direction of the State Librarian, at an expense not exceeding five hundred dollars (\$500). (S. P. 48.)

On motion by Mr. Robie of Cum-

berland, it was Ordered, that each member of the Senate be furnished a printed copy of the Senate advance journal pre-vious to each session, the advance journal to include all tabled matters.

#### Committee Reports

Mr Farnsworth from the Senate Committee on Senatorial Vote, on order of the Senate calling for report on the vote for Senators for the political years of 1933 and 1934, reported that a complete tabulation of the Senatorial votes is too bulky for the files, and is on file in the office of the Secretary of State for inspection and examination of the Senators.

Mr. WEEKS of Somerset: Mr. President, out of order, I wish to present the report of the Committee on Resolutions on the death of our late ex-President, Calvin Coolidge.
The PRESIDENT: The Senator

from Somerset, Senator Weeks, presents the report of the Committee on Resolutions on the death of our late ex-President, Calvin Coolidge. The Secretary will read the report.

The Secretary read:

"Whereas, God in His infinite wisdom has seen fit to remove from the midst of his fellow countrymen by the hand of death a guiding dis-ciple of sincere Americanism, Cal-

vin Coolidge, and "Whereas, the Senate of the State of Maine wishes to imprint upon its records its appreciation of his splendid character and unselfish public service, therefore be it

"Resolved, by the Senate of the

State of Maine

"That we take this occasion to express our heartfelt sorrow to the family which has been thus be-

reaved; and be it further

"Resolved, that we desire to express anew our appreciation of his useful life, his strength of character, his courage, his justice, his learning, his fairness, his worldly honors and the sense of security which he gave not only to his fellow citizens but to the world; and be it further

"Resolved, that by his parting this mortal life the United States of America has been deprived of a guiding hand which by its simplicity, sincerity and loving kindness appealed to friend and foe alike, and caused him to be admired, trusted and honored by all; and be it further

"Resolved, that the Secretary of the Senate transmit a copy hereof to the family of the deceased; and

be it ordered

"That as a further expression of respect for the memory of our be-loved ex-President, the Senate shall now stand adjourned until fourthirty o'clock on Tuesday afternoon, January seventeenth.
