Mr. LITTLEFIELD of York: Mr. President, this bill, and also the previous one, were referred in the House to the Committees on Agri-culture and Inland Fisheries and Game.

I now move that this bill be referred to the Committee on Agriculture in non-concurrence.

Thereupon, on motion by Mr. Weatherbee of Penobscot, the bill

was again laid upon the table pending reference.

The PRESIDENT: The Chair will say that he has consulted, either yesterday or this morning, with the chairmen of all joint standing committees except three and with one exception the chairmen of those committees have advised him that they can hold hearings on all matters that have been assigned to them, during the month of February. The chairman of the one committee which is the exception advised the Chair that that com-

mittee can complete all its hearings the week which sees the close of the month of February. If committee members will see to it in addition that reports are promptly filed in the bodies where the legislation originated we may make substantial progress and secure an early adjournment.
