Thereupon, on motion by Mr. Page of Somerset, the bill was retabled pending first reading.

The PRESIDENT: Is there any further business to come before the Senate under Orders of the Day? We have the longest calendar we have had for any day, for a printed calendar, with one exception. The Chair feels we are making reasonably good progress but we will be making better progress if we can shorten our calendar somewhat each day, or at least, keep it from lengthening. Is there any matter that can be disposed of at this session?

On motion by Mr. Viles of Kennebec, the Senate voted to take from the table, House Report from the Committee on Inland Fisheries and Game, "Ought to Pass" on "An Act relating to non-residents kindling fires and employment of guides" (H. P. 732, L. D. 339, tabled by that Senator on March 1st pending acceptance of the report in concurrence; and on further motion by the same Senator the report was accepted in concurrence, the bill was given its first reading and tomorrow assigned for second reading.
