Hence, the bill as it is written, if finally enacted, might tend to lead us into legal entanglements of some kind, which is the reason for the amendment. Amendment Thereupon, Senate "A" was adopted and the bill as amended by Senate Amendment "A" was passed to be engrossed in non-concurrence.

Mr. HOLMES of Androscoggin:

Mr. President, I do not want to
make a motion, but I will, in a moment yield the floor to the Chairman of the Committee on Taxation. Therefore I assume in order to properly have the floor, I must ask the privilege of the floor to speak on a question of personal privilege. The PRESIDENT: The Senator

may state his question.

Mr. HOLMES: Mr. President. desire to state in connection with the advocacy of the bill before the Committee and my consultations with the Department of Education I learned the information therefrom, which I think should be

made a matter of public record to set the Department of Education right insofar as it lies within my power.

The PRESIDENT: The Senator

may proceed.
Mr. HOLMES: Mr. President, this report of "ought not to pass" accepted in the House. I do not think, as one who advocated the bill before the Committee, and who be-lieves in it.—I do not think it would be worthwhile for the advocates to ask for a vote in the Senate. would be probably futile if the Senate took the opposite position from the House, and therefore, as I said, in a few moments I will yield the floor to the Chairman of the Committee on Taxation. But, I think, Mr. President, that there should be a public reply to a statement, quite in error, to be found in the Legislative Record of March 8th. In the debate in the House on this measure at Page 430, a member speaking said, "You have voted for new school buildings, you have supported that department (meaning the Department of Education) to limit of your ability and now comes a time when you must retrench, and you feel that you must retrench, and the reluctance that this department (meaning the Department of Education) shows in this retrenchment does not suit me at all. If they are the institution that we thought they were and that we helped to build up, it is a surprise to me that they do not come back to us in accord. They should not leave us in the gutter after our usefulness is gone."

Strong words, Mr. President,
I advocated this bill and believed that it was advisable for the welfare of the State, and I found that the Department of Education was strongly in favor of it, and the head of the Department of Education, Dr. Packard, appeared before the Committee on Taxation at the public hearing and advocated it. And I found then and have since,—and I think that is the cause of the misunderstanding in the mind of the member who made that statement which I have just read,-that there was a misunderstanding, which probably persists yet, that this was an effort backed by the Department of Education to impose more taxes on the people of Maine, whereas the contrary is the fact; if they had given the matter consideration,those who believed that way,—this measure would relieve to some extent the direct property taxpayers. and it would produce a revenue which would be allocated by the

which would be allocated by the terms of the bill, directly to the public state school fund.

If members, and the public who were opposed, could only have got that idea and realized it. I think much of the opposition would have evaporated, and also no such state-ments and criticism of the Department of Education would have been

I think everybody who is well informed in this Senate knows that the Department of Education is being conducted efficiently, and, if I may use a much abused term, patriotically, and that the Department does not want special favors and

has not asked for them.

I do not intend to deliver an eulogy upon the Department, its head, or any of its members. understanding.
I think that the Department Education is fortunate that it has at its head a learned and scholarly gentleman, and a capable and efficient business executive in Dr. Bert-

ram E. Packard. Now, Mr. President, I yield to the Senator from Cumberland, Senator

Mr. JACKSON of Cumberland: Mr. President, I thank the Senator for yielding, and without comment move the committee report, "Ought Not to Pass" be accepted in concurrence.

The motion prevailed and the "ought not to pass" report of the Committee on Taxation was accept-

ed in concurrence.

Mr. PAGE of Somerset: Mr. President, may I inquire whether or not this bill has been or is on the desks of the members here, and if so, if they have had time to read it. If not, I think perhaps it would be well to recess for a few moments.

The PRESIDENT: Does anybody desire to recess for a few minutes in order that they may read Legis-lative Doucments 918 and 919?

Mr. LITTLEFIELD of York: Mr.

President, I think there should be a recess that every member may have a chance to read these bills.

The PRESIDENT: The Chair will declare a recess until four-twenty.

AFTER RECESS

The Senate was called to order by the President.

On motion by Mr. Page of Somerset, under suspension of the rules and without reference to a committee, An Act for the Protection of Savings Banks and Depositors therein, (S. P. 590) (L. D. 918) was given its first reading.

Mr. HARMON of Hancock: Mr. President, this bill seems to me to be quite revolutionary. These, of course, are abnormal times, but there are features, it seems to me, in this bill, that should have a little consideration, and before the question is put through I would like to inquire as to the reason for putting this through at this time.

The PRESIDENT: The Senator from Hancock Senator Harmon, inquires through the Chair, of the Senator from Somerset, Senator Page, for an explanation of the reason why this bill should be enacted at this time. The Senator may reply, if he desires.

Mr. PAGE of Somerset: Mr. President, I supposed it was known to everybody why these bills were introduced at the present time. This first bill, Legislative Document 918 is for the protection of the depositors in savings banks. Savings banks now have the right, by going through the courts, and accomplishing the same thing. This does it in a much quicker way and accomplishes the same purpose. There are some banks probably,—I do not know of any,—which may have to take advantage of it. It is necessary legislation or would not have been introduced here now.

Mr. HARMON: Mr. President, if this has the backing of the Banking Committee of this State, and will do any good, I am for it. I do feel, personally, there are some of those clauses in this first bill that should be looked into. That is the way I feel about it and I want to register my feelings, and with that explanation I will withdraw my objection.

Thereupon, on motion by Mr. Weeks of Somerset, the rules were suspended and the bill was given

its second reading, and passed to be engrossed.

Sent down for concurrence.

On motion by Mr. Page of Somerset, the Senate voted to take from the table, An Act for the Protection of Trust Companies and Depositors Therein, (S. P. 589) (L. D. 919), tabled by that Senator earlier in today's session for printing under the joint rules and on further motion by the same Senator, under suspension of the rules and without reference to a committee, the bill was given its two several readings, and was passed to be engrossed.

Sent down for concurrence.

On motion by Mr. Page of Somerset Recessed, until the sound of the gavel.

AFTER RECESS

The Senate was called to order by the President.

From the House, out of order, Ordered, the Senate concurring, that notwithstanding the terms of the closing order adopted on the day of the convening of this Legislature, the separate bodies receive for consideration such measures as in the opinion of a majority of the body in which any measure is offered are designed solely for emergency relief in view of the existing financial and credit situation.

In the House, read and passed. In the Senate; Mr. LITTLEFIELD of York: Mr. President, it seems to me that I can see a place in that order where we could help the situation by inserting the word "banking" so that it would read "such banking meas-

ures" as might come in.

The PRESIDENT: May the Chair suggest to the Senator from York, Senator Littlefield, that if this order can be adopted in concurrence as it is worded, business will be considerably expedited. If we amend the order it then must go back to the House for concurrent action again. Under the order, if the Chair followed it correctly, it is left to the judgment of a majority of the body so that the Senator from York, Senator Littlefield, along with every other member of the Senate, will have an opportunity to oppose any offered legislation if he desires on the contention that it is not

banking legislation. Does that satisfy the Senator?

Mr. LITTLEFIELD: I am perfectly willing, Mr. President, that banking legislation should come in but I can see where things might come in under an order, if you open the doer, that could not come in under unanimous consent as it was before.

The PRESIDENT: May the Chair read the order again to the Senator?

Mr. LITTLEFIELD: Yes, Mr. President.

The order was again read.

The PRESIDENT: That does not open a very wide door and if the Senate will adopt this in its present form the issue will be a closed one and will not have to be again referred to the House and the Senator may argue properly against any submitted measure that it does not point to the relief of the existing financial and credit situation.

financial and credit situation.

Mr. LITTLEFIELD: That is all I care to argue, Mr. President. I am perfectly willing that anything of that nature should go in but I do know things that will come in to this Senate under this emergency if you open that up and I don't want it opened up. Now, if you can confine this to financial questions I am perfectly willing.

The PRESIDENT: The Chair believes that that confining can be had under the order as it reads, but if the Senator desires to offer an amendment to further tighten it the Chair assumes that the Senate will grant time for the preparation

of the amendment.

Mr. LITTLEFFELD: Mr. President, I do not want to trig the wheels of justice here at all, only it did come into my mind that "such banking measures" might be added there and possibly keep everything else out and that is my whole purpose, to keep things out and go on as fast as we can, but I am perfectly willing that all banking measures should go in, in this emergency.

The PRESIDENT: The Chair cannot do any more than to restate that it was the purpose of those who drafted the order, the Senator from Somerset, Senator Weeks, and the Chair, to confine the opening of the door to emergency financial and credit matters. Whether or not there would be danger in adding

the word "banking" the Chair cannot say.

Mr. LITTLEFIELD: The Senator from Somerset, Senator Weeks, informs me that it will hold us strictly to banking measures and I amperfectly willing to take his word for it.

The PRESIDENT: The Senate has heard the order. Is it the pleasure of the Senate that the order receive passage in concurrence.

ceive passage in concurrence.

Thereupon, the order was passed

in concurrence.

The PRESIDENT: It has been suggested to the Chair that there may be some advantage in increased knowledge on behalf of the members of the Senate in having a frank and free discussion of this bill which is not now before the Senate but is in the hands of the Clerk of the House, not yet admitted to the House. For that reason the Chair would suggest that the Senators remain in their seats and that entirely off the record, unless the members of the Senate desire it in the record, there be as frank, full, free and open discussion of either or both of these measures as any member of the Senate desires.

Mr. HOLMES of Androscoggin: Mr. President, would it not be necessary for the Senate to resolve itself into a committee of the whole in order to discuss the matter with-

out a record.

The PRESIDENT: If the Senator desires the Senate may resolve itself into a committee of the whole. The Chair thought it was the suggestion of the Senator that entirely off the record and informally during a recess the Senate discuss the matter.

Mr. HOLMES: I understand and thank the Chair.
