SENATE

Friday, March 17, 1933 Senate called to order by the President.

Prayer by the Rev. J. Reid Howse of Hallowell.

Journal of Yesterday read and approved.

At this point Mr. Blaisdell of Hancock was escorted to the Chair, the President retiring, amidst the applause of the Senate, the members rising.
