#### SENATE

Tuesday, December 5, 1933. Senate called to order by the

President. by the Rev. A. T. Mc-Prayer Whorter of Augusta.

Journal of yesterday read and approved.

The PRESIDENT: Before we proceed to the business of the morning the Chair would like to say again what he tried to say yesterday, that it is the hope of the presiding of-ficers and the clerical offices of the two branches of the Legislature that all legislation may be immediately introduced.

We have assumed the responsibilwhich we hope the separate itv. bodies will confirm, of holding two sessions daily this week for the purpose of receiving legislation and getting it referred so that next week may be devoted to committee hearlings, the first of the week, and to legislative work thereafter. All committee chairmen are, of

course, members of the Senate and if at the conclusion of this morning's session the committees will organize and assign, so far as possible, all the bills for hearing next Tuesday we may make reasonably rapid progress.

We hope to have a session Friday morning which will finally catch every bill and resolve that is to be introduced into this session so that every bill may be in the hands of the proper committee not later than Friday and before the session this morning is over a closing order will be introduced which we hope you will approve.

We will have meetings of the committee on reference of bills at one o'clock daily for the purpose of getting reference at the afternoon sessions.
