Wednesday, January 2, 1935.

The roll being called the following Senators-elect responded to their names:

Ashby, Bartlett, Billings, Bissett, Blaisdell, Blanchard, Bodge, Burkett of Cumberland, Burkett of Knox, Burns, Carll, Cowan, Fernald of Waldo, Fernald of York, Friend, Goodwin, Harmon, Hathaway, Huster, Lackton, Moster, Mo sey, Jackson, Martin, McDonald. Pillsbury, Pinansky, Potter, Schnurle, Thatcher, Tompkins, Weeks of Somerset, Winn and Wor-Pillsbury,

Thirty-one Senators-elect answering to the roll call the Secretary declared that a quorum was present. On motion by Miss Martin of

Penobscot.

That Senator-elect was charged with a message to the Governor and Council informing them quorum of the Senators-elect to the Eighty-seventh legislature was present in the Senate chamber ready to take and subscribe to the oaths of office required by the Constitu-tion to qualify them to enter upon the discharge of their official duties.

Subsequently Miss Martin reported that she had delivered the message with which she was charged and the Governor was pleased to reply that he will attend upon the Senators-elect forthwith for the purpose of administering to them the oaths of office required by the Constitution.

Senators Take Oath

Thereupon the Governor, the Honorable Louis J. Brann attended

by the Executive Council came in before whom the Senators-elect took and subscribed the oaths of office required by the Constitution.
The Governor and Council then

withdrew.

On motion by Mr. Friend of Somerset Senators Friend of Somerset, Fernald of Waldo and Bodge of Kennebec were appointed a committee to receive, sort and count votes for President of the Senate.

Having attended to this duty Mr. Friend for the committee reported

as follows:

Whole number of votes cast 31. Necessary for a choice 16.

Harold E. Weeks had 21; John A. McDonald had 10.

Which report was read and accepted and the Secretary declared the Honorable Harold E. Weeks duly elected President of the Senate of the Eighty-seventh Legislature.

Mr. Weeks was escorted to the chair by Mr. Blaisdell of Hancock and thereupon addressed the Senate as follows:

The PRESIDENT: Members of the Eighty-seventh Legislature, it is impossible by mere words for me to express to you the extreme satiswhich you faction and pleasure have given me this morning by electing me to this most exalted position. It is of personal satisfaction to me, especially because of the fact that over a period of thirty years I have served not only in the highest position, now, which the Legislature affords, but also in its humblest position.

In accepting the great responsibility which you have placed upon me I know that I do not now represent any individual in the State of Maine or any particular party, creed or faction. I am here for the purpose of acting for the interests of every individual in the State of Maine and for the interests of each and every one of you as individuals.

In carrying out the luties of this office I ask your cooperation. I know that I will make mistakes because I am only human as are the rest of us, but I want you to know and feel that when I do make a mistake it will be a mistake in mind and thought rather than in heart.

Again thanking you for this extreme honor which you have given me, I await your pleasure.

On motion by Mr. Burkett of Cumberland, the Senate voted that a committee be appointed to receive, sort and count votes for Secretary of the Senate.

On motion by Mr. McDonald of Washington, the Senator from Pis-

cataquis. Senator Hathaway, was authorized to cast one ballot on the part of the Senate in favor of Royden V. Brown for Secretary of the Senate.

This was done and Royden V Brown of Skowhegan, was declared duly elected Secretary of the Senate for the political years 1935 and 1936.

At the request of the President

Mr. Burkett of Cumberland escorted the Secretary-elect to the Council chamber for the purpose of taking and subscribing the necessary oaths of office to qualify him to enter upon the discharge of his official duties.

Subsequently Mr. Burkett reported subsequently Ar. Burkett reported to the Senate that he had attended to the duty assigned him, and that Royden V. Brown had, before the Governor and Council, taken and subscribed the oaths of office required to qualify him for the discharge of the duties of the Secretary of the Senate.

On motion by Mr. Jackson of Sagadahoc, the Senate voted that a committee be appointed to receive, sort and count votes for As-

sistant Secretary of the Senate.
On motion by Mr. McDonald of
Washington, the Senator from Waldo, Senator Fernald, was authorized to cast one ballot on the part of the Senate in favor of Chester T. Winslow for Assistant-Secretary of the Senate. This was done and Chester T. Winslow of Raymond was declared duly elected Assistant-Secretary of the Senate

for the political years 1935 and 1936.

Mr. Winslow subsequently appeared before George W. Leadbetter, Esq., authorized Dedimus Potestatem and took and subscribed the oaths of office.

On motion by Mr. Hathaway of Piscataquis, the Senate voted that a committee be appointed to receive, sort and count votes for Sergeant at Arms of the Senate.
On motion by Mr. McDonald of Washington, the Senator from Ox-

Senator Bartlett, was authorized to cast one ballot on the part of the Senate in favor of Mel-len H. Tryon for Sergeant at Arms of the Senate.

This was done and Mellen H. Tryon of Pownal was declared duly elected Sergeant at Arms of the Senate for the political years 1935 and 1936

On motion by Mr. McDonald of ashington, the Senator from Washington, Arostook, Senator Ashby, was authorized to cast one ballot on the part of the Senate in favor of Louis R. Fowler for Assistant Sergeont geant at Arms, John K. Forhan for Postmaster, Waldo H. Clark for Doorkeeper, Roy S. Humphrey for Page and Harlan Wadleigh for Page.

This was done and the above were declared duly elected to their several offices for the political years

1935 and 1936.

On motion by Mr. Burkett of Cumberland that Senator was charged with a message to the House of Representatives, informto the ing that body that the Senate had organized by the choice of the Honorable Harold E. Weeks as President, Royden V. Brown as Secretary and Chester T Winslow as Assistant Secretary.

That Senator retired and subsequently reported that he had delivered the message with which he

was charged.

On motion by Mr. Blaisdell of Hancock that Senator was charged with a message to the Governor and Council informing them that the Senate had organized by the choice of the Honorable Harold E. ORDERED, that the State Librarian be directed to provide each officer and member of the Senate with a copy of the Acts and Resolves of the Eighty-sixth Legislature.

On motion by Mr. Bissett of Cumberland, it was

ORDERED, that a committee of seven be appointed by the President to whom the returns of votes for Senators for the political years of 1935 and 1936 shall be referred for examination and report.

The President appointed Senators Bissett of Cumberland, Pinansky of Cumberland, Blanchard of Franklin, Burkett of Knox, Carll of York, Worcester of Washington. Goodwin of Oxford,

On motion by Mr. Tompkins of

Aroostook, it was

ORDERED, that the Official Reporter of the Senate be authorized to procure the services of a type-writing operator during the present session at an expense not exceeding \$400; also an assistant reporter at an expense not exceeding \$700; for the preparation and completion of the Legislative record.

On motion by Mr. Burns of Aroos-

took, it was

ORDERED, that the Secretary of the Senate be authorized to secure the services of three stenographers for the present session; one for the office of the President and two for the office of the Secretary.

On motion by Mr. Pinansky of Cumberland, it was

ORDERED, that the Secretary of the Senate prepare and have printed 150 diagrams of the Senate Chamber for the use of the Senate.

On motion by Mr. Fernald of Waldo, it was

ORDERED, that \$1000 be made available to change the upholstery in the Senate Chamber, and the drapery back of the President's chair, so that it will properly match the carpet; this to be carried out under the direction of the Secretary of the Senate.

On motion by Mr. Schnurle of

Cumberland, it was ORDERED, that the Secretary of the Senate purchase such stationery, office supplies and equipment as may be needed to carry on the business of the Senate.

On motion by Mr. Blanchard of Franklin, it was

ORDERED, that the rules and orders of the Senate of the Eightysixth Legislature be the rules and orders of this Senate.

On motion by Mr. Blaisdell of

Hancock, it was ORDERED, that the Secretary of State be directed to furnish for the use of the Senate, four copies of the Revised Statutes, of the State, one copy each of the Holy Bible, Webster's International Dictionary, Bouvier's Dictionary and Reed's Parliamentary Rules.

On motion by Mr. Harmon of

Hancock, it was

ORDERED, that Charles P. Lyof Augusta be appointed Official Reporter of the Senate with the same compensation as paid at the last regular session of the Legislature.

On motion by Mr. Bodge of Ken-

nebec, it was

ORDERED, that the Senate hold one session a day commencing at ten o'clock in the forenoon until otherwise ordered.

On motion by Mr. Pillsbury of Kennebec, it was ORDERED, that the President of the Senate be authorized to appoint a Folder for the Senate.

Subsequently, the President appointed Wallace Jewell as Folder.

On motion by Mr. Bartlett of Oxford, it was

ORDERED, that the State Librarian be directed to provide each officer and member of the Senate with a copy of the Revised Statutes.

On motion by Mr. Pillsbury of Kennebec, it was ORDERED, the House concurring,

that A. G. Robinson be State House Investigator during the present session of the Legislature at the same rate of compensation paid Mr. Robinson during the last session, the same to be charged to Legislative expense.

Sent down for concurrence.

On motion by Mr. Hathaway of

Piscataquis, it was ORDERED, the House concurring that the Joint Rules and Orders of the Eighty-sixth Legislature be the Joint Rules and Orders of this Legislature. (S. P. 1)

Sent down for concurrence.

At this point a message was re-ceived from the House of Representatives, informing the Senate that that Branch had organized by the choice of Hon. Nathaniel Tompkins of Houlton as Speaker, Harvey R. Pease as Clerk, and Earl L. Wing as Assistant Clerk.

On motion by Mr. Winn

Androscoggin, it was ORDERED, the House concurring, that the Secretar of the Senate and Clerk of the House jointly prepare the Senate and House Register, and that 5000 copies be printed for the use of the Legislature. for the (S. P. 2)

Sent down for concurrence.

Mr. Fernald of Waldo presented the following order and moved its passage

ORDERED, the House concurring,

that a Committee on Social Welfare be created.

Mr. BLAISDELL of Hancock. Mr. President, for the purpose of having an opportunity to think the matter over and of learning just what is meant by the order I move that it lie upon the table.

The motion to table prevailed.

Mr. Bartlett of Oxford presented the following order and moved its

passage:

ORDERED, the House concurring, that free telephone service be pro-vided for each member of the Sen-ate and House to the number of twenty-five calls, of reasonable duration, from Augusta to points with-in the limits of the State of Maine, and that each member of the Senate and House be provided with a card to be certified to by the Secretary of State or his deputy; the cost of this service to be paid to the New England Telephone and Telegraph Company at regular tariff rates. (S. P. 3)

On motion by Mr. Schnurle of Cumberland the order was laid upon

On motion by Mr. Goodwin of Oxford, it was

ORDERED, the House concurring, that all matters pertaining to printing, binding, advertising, committee record binders, paper supplies and rubber stamps be referred to the Superintendent of Public Printing who shall direct the handling of such matters. (S. P. 4)

Sent down for concurrence.

On motion of Mr. Cowan of Lin-

coln, it was

ORDERED, the House concurring, that the Secretary of State be authorized to furnish wrappers and postage stamps for each member and officer of the Senate and House not exceeding \$5.00 in amount each for the purpose of distributing the various reports as they may desire to mail to the citizens of the State. (S. P. 5)

Sent down for concurrence.

On motion by Mr. Winn of Andro-

scoggin, it was

ORDERED, that the Secretary of the Senate be directed to furnish each member and officer of the Senate during the present session with three daily newspapers printed in the State, as each member and officer may select.

On motion of Mr. Thatcher of Penobscot, it was

ORDERED, the House concurring, that no bill for private or special legislation be received by this legislature after four o'clock in the afternoon on Thursday, January 31, 1935 except by unanimous consent in the body in which it is introduced and further.

That any bill for private or special legislation which shall be received in either body of this legislature by consent unanimous unanimous consent after four o'clock in the afternoon on Thursday, January 31, 1935 shall be re-ferred to the Eighty-eighth Legis-lature if unanimous consent for its reception is not given in the other body in concurrence, and further

That the Secretary of the Senate cause a copy of the above orders to be published in all the daily and weekly papers of the State, commencing January 10, 1935, and continuing up to and including January 31, 1935. (S. P. 6) Sent down for concurrence.

On motion by Mr. Fernald of Waldo, it was

ORDERED, the House concurring, that the returns of votes for Governor, given in the several cities, towns and plantations of the State for the political years 1935 and 1936 be referred to a joint select committee of seven on the part of the Senate with such as the House may join. (S. P. 7)

Sent down for concurrence.

The President appointed as Senate members of this Committee:

ORDERED, the House concurring, that three hundred and fifty copies of the Legislative Record for the session of 1935 be printed and bound, one copy each for the members of the Senate, House of Representatives, and the Secretary of Senate and Clerk of the House, and the remainder to be deposited in the State Library for exchange and li-

ORDERED, that three hundred and fifty copies of the Legislative Record be printed in pamphlet form for distribution from day to day to members of the legislature and the departments, under the direction of the Document Clerk, and be it further

ORDERED, that a suitable index be prepared for such Legislative Record under the direction of the State Librarian, at an expense of the exceeding, five hundred solves exceeding five hundred do (\$500). (S. P. 8)

ORDERED, the House concurring, that the Bureau of Purchases be directed to furnish to the Supt. of Public Printing, postage on all cor-respondence relative to advertising hearings during committee present session, same to be charged to legislative expense. (S. P. 9)

that the members and officers; of the legislature be furnished with express and parcel transportation for all packages and department reports in a sum not exceeding five dollars for each member and officer thereof, and that such transporta-tion be furnished and expended under the direction of the State Library Department and the unexpended balance at the close of the year 1935 shall be available for use in 1937. (S. P. 10)

Ordered, the House concurring, that each member and officer of the legislature be furnished with a fountain pen. (S. P. 11)

On motion by Mr. McDonald of

Washington, it was

ORDERED, the House concurring, that no bill or resolve be received by this legislature after four o'clock in the afternoon on Thursday, February 7, 1935, except by unanimous consent in the body in which it is introduced, and further,

ORDERED, that any bill or resolve which shall be received in either body of this legislature by unanimous consent after four unanimous consent after four o'clock in the afternoon on Thursday, February 7, 1935, shall be referred to the Eighty-eighth Legislature if unanimous consent for its reception is not given in the other body in concurrence. These orders body in concurrence. These orders shall not apply to bills reported by any joint standing or joint select committee in the regular course of business, nor to such bills and re-solves as are intended only to facilitate the business of the Eighty-Legislature; and be seventh further

ORDERED, that the Secretary of the Senate cause a copy of the above orders to be published in all the daily and weekly papers of the state, commencing January 9, 1935 and continuing up to and including January 31, 1935. (S. P. 12)

Recessed until two o'clock P. M.

AFTER RECESS

The Senate was called to order by the President.

On motion by Mr. Bissett of Cum-

berland, it was

ORDERED, that a message be sent to the House of Representatives proposing a Convention of the two branches of the Legislature forthwith in the Hall of the House for the purpose of electing a Secretary of State, Treasurer of State, Attorney General, and seven Executive Councillors.

The Secretary delivered the mes-

sage.
Subsequently a message was received from the House of Representatives by Mr. Pease its Clerk, announcing that that branch concurred in the proposition of the Senate for a Joint Convention for the purpose of electing a Secretary of State, Treasure of State, Attorney General and seven Executive Councillors.

Thereupon the Senate retired to the Hall of the House of Representatives, where a Joint Conven-

tion was formed.

Orders of the Day

On motion by Mr. Hussey of Kennebec, the Senate voted to reconsider its action taken earlier in today's session whereby it was ordered that one thousand dollars be made available to change the upholstery in the Senate Chamber; and on fur-ther motion by the same Senator the order was laid upon the table pending passage.

On motion by Mr. Schnurle of Cumberland, the Senate voted to take from the table, Joint Order relative to free telephone service, tabled by that Senator earlier in today's session pending passage.
Thereupon, that Senator offered

the following amendment and moved

its adoption:
"That the order be amended by

striking out the words 'twenty-five' and including in their place the word 'fifty'."

The amendment was adopted and

on further motion by the same Senator the order as so amended received passage.
Sent down for concurrence.

On motion by Mr. Hussey of Kennebec, the Senate voted to take from the table, order relative to fountain pens, tabled earlier in to-day's session by that Senator pending passage; and on further motion by the same Senator the order was indefinitely postponed.

On motion by Miss Martin of Penobscot.

Adjourned, until tomorrow morning at ten o'clock.
