Wednesday, January 30, 1935. Senate called to order by the President.

The PRESIDENT: The Chair will state that the bills were introduced from the House where they were referred to the Committee on Inland Fisheries and Game, no action as to their reference having been taken in the Senate, and the pending question being reference to a committee.

Thereupon, the bill (L. D. 76) was referred to the Committee on Legal Affairs in non-concurrence.

On motion by Mr. Blaisdell of Hancock, the Senate voted to take from the table, An Act relating to intoxicated persons carrying guns while hunting (H. P. 303) (L. D. 77), tabled on January 24th by that Senator pending reference in concurrence; and that Senator yielded to the Senator from Cumberland, Senator Schnurle.

Thereupon, on motion by Mr. Schnurle of Cumberland, the bill was referred to the Committee on Legal Affairs in non-concurrence.

Mr. JACKSON of Sagadahoc: Mr. President, this is a matter in which I have little personal interest. I introduced it at the request of a group troduced it at the request of a group of Cumberland County gentlemen. As I view it, it is purely a fire protection matter. We read in the appers in fully 75% of cases of fire that the fire was caused by defective wiring and this is aimed at remedying that condition to some extent. It seems to me that the proper place for it to be referred is to the Committee on Mercantile is to the Committee on Mercantile Affairs and Insurance and I move that it be so referred.

Thereupon, the bill was referred to the Committee on Mercantile Affairs and Insurance, and five hundred copies ordered printed.

The PRESIDENT: The Senator from Cumberland, Senator Schnurle, wishes to ask the Senator from Hancock, Senator Blaisdell, a question through the Chair and the Senator from Hancock (Senator Blaisdell) may reply if he so desires.

Mr. SCHNURLE: Mr. President, I would like to ask whether it will be necessary to secure unanimous consent for the introduction of any bills that may be in the hands of the Revisor of Statutes as of four

o'clock tomorrow afternoon. Mr. BLAISDELL: Mr. President, the only answer that I can give to the Senator from Cumberland (Senator Schnurle) is that I had hoped that the President might make a statement amplifying my own remarks I had hoped that the President would either say that the Senator from Hancock (Senator Blaisdell) was in error or that what I did say was according to our custom.

Mr. SCHNURLE: Well, Mr. President, with the permission of the Senator from Hancock (Senator Blaisdell) I will ask the question

of the President.

The PRESIDENT: The Chair will state that he feels that under the work which the Senate is doing full opportunity should be given to every member to present matters which they have for consideration and if matters are in the hands of the Revisor of Statutes in course of preparation that they would constitute exceptions to the rule and could be offered without unanimous consent of the Senate.
