Thursday, January 31, 1935.

#### IN THE SENATE

The Senate was called to order by the President.

#### Orders of the Day

On motion by Miss Martin of Penobscot, the Senate voted to take from the table, An Act to amend Chapter 125, Section 46 of the Revised Statutes relating to clerk hire in Penobscot County (S. P. 229), tabled on January 29th by that Senator pending reference; and on further motion by the same Senator the bill was referred to the Committee on Salaries and Fees.

On motion by Mr. Blaisdell of Hancock, the Senate voted to take from the table, Joint Order relative to creating a committee on Social Welfare, tabled on January 2 by that Senator pending passage; and that Senator yielded to the Senator from Waldo, Senator Fernald.

from Waldo, Senator Fernald. Mr. FERNALD of Waldo: Mr. President, this order in regard to the creation of a committee on social welfare was introduced by myself at the request of one of our state officials and since there does not seem to be any need for this committee at this time I ask the consent of the Senate to withdraw the order.

Thereupon unanimous consent was granted to withdraw the order.

On motion by Mr. Burkett of Cumberland the Senate voted to take from the table, Senate Order relative to changes in the County System of Government, tabled on January 22nd by that Senator pending passage.

Mr. BURKETT of Cumberland: Mr. BURKETT of Cumberland: Mr. President, I think the Senate has done remarkably well, at the end of the fourth week, to have so few matters on the calendar and I want to do everything I can to cooperate and keep the calendar as clear as possible. However, I felt that this order needed some investigation and that is why I have had it on the table for a week or more.

I have investigated into the matter somewhat, I have talked with the County Commissioners in my own county for one thing, and I find there as I do everywhere else absolutely no movement or thought of consolidation of counties in their minds. In my county, for instance, it is so well administered that the County Commissioners have just announced a reduction in the county tax for the coming year to be assessed on the towns of that county. In the neighboring county of York they have just completed the rebuilding of a court house, part of which was destroyed in a very disastrous fire, and now have one of the best county buildings in the State and are making plans for the celebration of the three hundredth anniversary of the founding of York County, a very worthy movement, I think, in which the State will be asked to cooperate.

I have noticed that the sponsor of the order, the Senator from Waldo (Senator Fernald), is reported to have said in an address at either Hallowell or Gardiner, I have forgotten which, without mentioning his own county in connection with this order, that the counties of Sagadahoc and Lincoln are two counties which might be properly consolidated. I don't know whether there has been any talk in those counties about this matter but I do feel in connection with it —and this is the main reason why I am going to make the motion that I will make—that if there is any idea in any two counties of the State that they should consolidate, that that idea should be developed in the counties themselves rather than the State taking the initiative and doing anything about it. For concerned, I believe, in the financial administration of the affairs of counties as long as the county is properly administered, under our statutes. I cannot see how the State can be concerned if the people want to expend or propose to spend money extravagantly to do anything in connection with their county government, so I believe that if any two counties in the State have any idea that they want to consolidate, or more than two counties, they can get together and work out a proper adjustment of their funded debts, decide where the seat of government is to be, and then submit the matter to the State for approval rather than have the State attempt to force them into any such situation.

into any such situation. That, briefly, is the reason I am now going to move that the order be indefinitely postponed.

Now gong of more that the order of the order Mr. FERNALD of Waldo: Mr. President, I have listened with a great deal of interest to the remarks of the Senator from Cumberland (Senator Burkett) but I still feel that there would be no injustice done to Cumberland County or to Sagadahoc County or to Knox County or any other county, in the passage of this order, and furthermore, I do not see where it would cost the State of Maine a single penny because there is no appropriation that goes with the order.

I will read the order again so that perhaps we can be brought up to date in this matter: "Ordered, the House concurring, that a committee of seven members be appointed by the Governor, three from the Senate and four from the House, to study the advisability of changes in the county system of government, and report their recommendations to the Eighty-eighth Legislature." Which does not say that any changes will be made but it is just a commission to study and make suggestions. It may be that in Cumberland County it will be found that we might want to copy their method of doing things.

I received this morning a letter from the University of Maine that I think typifies my feeling in this matter. This is in regard to the Farm Bureau. The Farm Bureau, you will understand, is not divided up in its activities along county lines but I believe originally was along county lines but since then they have consolidated, and this is the letter I have from the Extension Service: "In organizing the Farm Bureau we combined Androscoggin and Sagadahoc counties into one unit and Knox and Lincoln counties into another unit. This combination gives the agent serving these units about the same number of communities to serve as is found in our other counties" meaning, of course, Cumberland County and Aroostook and the larger counties—"and reduces the cost both to the counties and to the state. Each Farm Bureau received two thousand dollars of county funds. It, therefore, results in a total saving from this source of four thousand dollars."

Now, if in just this small way the Farm Bureau in county consolidation of their activities can save four thousand dollars I am inclined to think that if this committee is appointed from the Senate and from the House that perhaps we might possibly find a few ways of saving a few dollars in our other county activities. There is nothing unusual about this order. As a matter of fact Maine is behind the other states in the Union in making these studies and for my part I don't see any harm in studying the question; I don't see any harm in three Senators and four members of the House reporting to the next Legislature how they feel about it, and I don't find in this order anything mandatory or anything binding upon this Legislature. And, furthermore, it does not cost anybody any money except, perhaps, some personal expense that the committee themselves might find it necessary to expend, which is entirely optional with them.

Those of you from Bangor who read the Bangor Commercial will perhaps recall the caricature of county government that was displayed last week in the Commercial. It was a cartoon that typifies the situation I am trying to present before the Senate. And now I find an article commenting upon Governor Curley's attitude towards County Government in Massachusetts which in part reads as follows: "Now comes the long-awaited leadership. Gov. Curley's demand for abolition of County Government is one of the soundest points in his program. He will have a battle on his hands to put it in force. The county rings will seek to block a constitutional convention and they will have strong support in the Legislature, where half the members will be worrying about the Governor's proposal to abolish their jobs too. But the great unorganized support of the public will be with the Governor, who is a deft organizer and a great battler. If he can organize this public support and make its force felt on obstructionists who exist by public favor, he should win the battle."

Now, gentlemen, I have one point of view about this proportion. The Senator from Cumberland (Senator Burkett) has another. The Senator from Cumberland (Senator Burkett) may be right and, on the other hand, there is a possibility that I may be right. I see no harm in the passage of this order because, as I have pointed out, it is binding in no way and costs nobody any money, and if we can have a little information I am sure that in these trying days when the costs of government are so pressing upon the home-owner and the shop-owner and the industrialist. if we can alleviate an unnecessary tax burden from those persons I think it is our duty to seek the light; and that is all I am asking this body to do, to seek the light, and then govern themselves accordingly.

I trust that the motion of the Senator from Cumberland (Senator Burkett) will not prevail.

ator Burkett) will not prevail. The PRESIDENT: The question is on the motion of the Senator from Cumberland (Senator Burkett) that the order relative to changes in the county system of government be indefinitely postponed.
