Mr. BURNS of Aroostook: President, I offer Senate Amendment "A" to Legislative Document 399, An Act relating to kidnapping, and in explanation I will say that under the statutes of the State of Maine a respondent convicted of a felony is sentenced to the State Prison and that is a term used rather than "penitentiary" and this amendment is offered to strike out the word penitentiary so that the act will refer to the State Prison.

Thereupon the Secretary read Senate Amendment "A": "Senate Amendment 'A' to Legislative Document 399 entitled 'An Act relative to kidnapping'. Amend Section 18 by striking out in the fourteenth line of said Section 18 the words 'in the

penitentiary'.

Thereupon, Senate Amendment "A" was adopted and the bill as amended by Senate Amendment "A" was next Tuesday assigned for

second reading.
