Friday, March 22, 1935.

Senate called to order by the President.

Prayer by the Rev. H. E. P. Pressey of Augusta.

Journal of yesterday, read and approved.

Mr. FERNALD of Waldo: Mr. President, I move that we substitute the bill for the report. In regard to the matter before us this morning, Legislative Document 267, you will see by the printed bill that all that act proposes to do is to say to the State of Maine, the State Treasurer, that in the depositing of the funds of the State he shall deposit those funds with the banking institutions created under the laws of Maine and with the banks of Maine which have been created been created under said laws that pay to the State of Maine, taxes. You will find that in striking out the words "national banks" the thought is that national banks which thus far have seen fit to go into the field of the savings bank business, although gs bank business, although were not originally chartered for that purpose, since they have seen fit to go into that field of ac-tivity and compete with our state institutions and thus seek under the cloak of the fact that they are in-strumentalities of the national government, to seek exemption from taxation. I feel that it is time in this State, when we understand the needs of the times, when we understand that the State is seeking so far as possible to bolster up its reverue and to increase its appropriations as far as possible, I feel that if at this time we can in some little way aid the trust companies and savings banks, banks that are gradually decreasing and gradually going out of existence because of this unfair competition and at the same time bring an added revenue into the State treasury, I feel that it is our duty as representatives of the people to protect our own in-stitutions and put the business of banking in Maine upon a basis of fair competition, a basis of a square deal for all regardless of whether you are on the right hand side of the street or on the left hand side of the street.

The theory back of it is not new. The theory was promulgated, at least twenty years ago, by a tax commission appointed by a Republican governor as the result of an act of a Republican Legislature, and of course I do not rise as a member of this Legislature seeking to increase the money available for the general activities of the government with any misapprehension as to what will be the final outcome of this bill because we know that in the last twenty years in Maine not a single reform in banking of any consequence as far as the people are concerned has ever been enactd by a Legislature. But I do say this, that I think we are perpetuating an injustice upon the savings banks of Maine when we help an institution created by the Federal Government to come in and compete with them but still to seek an exemption under their cloak as an instrumentality of the Federal Government.

This bill would bring into the State treasury, without any added expense, a considerable amount of money and at this time when we realize that money is very cheap and the banks are not wanting it, the national banks are not opposed to it. I think the matter is simple enough and it has been presented before you, and the disposal of this mater lies entirely in your hands. And, Mr. President, when the vote is taken I ask for a division.

The PRESIDENT: The Senator from Waldo, Senator Fernald, moves to substitute bill, An Act relating to the deposit of state funds (S. P. 267) (L. D. 267) for the report of the committee which is "ought not to pass" and the same Senator asks for a division.

A division of the Senate was had.

One having voted in the affirmative and twenty-seven opposed the motion to substitute did not prevail.

Mr. PINANSKY of Cumberland: Mr. President, apparently I was absent from the Senate Chamber when item number six on page five, was taken up. Under that item Mr. Burkett from the Committee on Military Affairs on "Resolve directing the Governor to proclaim October 11th of each year 'General Pulaski's Memorial Day' (S. P. 425) reported that the same ought not to pass.

With all due respect to the Senator from Cumberland, Senator Burkett, I am afraid that he did not go into the matter as thoroughly as he might have and I feel now that on account of the similarity, at least in sound, between that name and my own I would like opportunity to look into the geneology of the Pulaski family and see whether there is any relation there between his family and mine so that I may decide how to vote upon the matter

Since I was apparently absent when the report was read I will ask that this matter be laid upon the table.

The PRESIDENT: The Senator from Cumberland, Senator Pinansky, moves that the Senate reconsider its action taken earlier in today's session whereby report from the Committee on Military Affairs "Ought not to pass" on Resolve directing the Governor to proclaim October 11th of each year General Pulaski's Memorial Day (S. P. 125) was accepted.

Mr. BURKETT of Cumberland: Mr. President, I ask for a division. The PRESIDENT: And the Senator from Cumberland, Senator Burkett, asks for a division.

A division of the Senate was had. Sixteen having voted in the affirmative and ten opposed, the acceptance of the report was reconsidered.

Thereupon, on motion by Mr. Pinansky of Cumberland, the resolve and report were laid upon the table pending acceptance of the report.

On motion by Mr. Winn of Androscoggin, the Senate voted to reconsider its action taken earlier in today's session whereby it accepted the report of the Committee on Pensions, "legislation inexpedient," on bill, An Act relating to old age pensions (S. P. 427) (L. D. 517); and on further motion by the same Senator the bill and report were laid upon the table pending acceptance of the report.

On motion by Miss Martin of Penobscot, the Senate voted to reconsider its action taken on the previous legislative day whereby the report of the Committee on Legal Affairs "Ought not to pass" on bill, An Act relating to State planning and development (H. P. 1331) (L. D. 539) was accepted in concurrence; and on further motion by the same Senator the bill and report were laid upon the table pending acceptance of the report in concurrence.

Thereupon, that Senator offered Senate Amendment "A" and moved its adoption: "Senate Amendment 'A' to House Paper 314, Legislative Document 75, entitled 'An Act relating to fees of jurors.' Amend said bill by striking out in the sixth line thereof the figure '\$5' and inserting in place thereof the figures '\$4.50'; and by inserting in the seventh line

thereof, before the word 'included' the word 'not'."

Thereupon, on motion by Mr. Schnurle of Cumberland, the bill and amendment were laid upon the table pending adoption of Senate Amendment 'A".
