"STATE OF MAINE

Penobscot SS:

Indian Island, Old Town, Maine,

December 3rd, 1936. TO WHOM IT MAY CONCERN: This is to certify that at the general election of the Penobscot Tribe of Indians, held in accordance with Section 282, Chapter 1 of the Laws of Maine, 1933, on the first Tuesday of November, 1936, John S. Nelson was duly elected as Representative to the State Legislature for the term of two years, beginning with the first Wednesday of January, 1937, and ending with

the first Tuesday of November, 1938. (Signed) FLÅGG CUMMINGS Indian Agent."

The SPEAKER: The Chair understands that the Representative of the Penobscot Tribe of Indians, Mr. John S. Nelson, is in attendance and will ask the Sergeant-at-arms to escort the gentleman to Seat No. 152.
