Tuesday, February 23, 1937.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Hughes of

Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

Senate Bills and Resolves in First Reading

S. P. 304, L. D. 507: An act relat-

ing to motor vehicles.

S. P. 185, L. D. 287: Resolve changing the name of North Peaks on Mount Katahdin to Howe Peaks and naming Thoreau Spring on said mountain.

S. P. 93, L. D. 508: Resolve granting authority to the Forestry Department to sell certain lands.
