Report of a Committee

Mr. Shesong from the House Committee on Elections on Communication from the Attorney General reported that the communication be placed on file and that the House adopt the Resolution submitted as follows:

HOUSE RESOLUTION

Whereas, on January 1, 1941, Hon. Frank I. Cowan of Portland, Representative Elect to the 90th Legislature from Portland, was duly elected and qualified as Attorney General of the State of Maine, and

Whereas, said Frank I. Cowan
did not qualify as a member of the
90th Legislature by taking the oath
to qualify him to perform the
duties of said office, and

Whereas, the position of Attorney General and that of Representative to the Legislature are incompatible under the Constitution.

Now, Therefore, be it resolved that a vacancy exists in the delegation of Representatives to the Legislature from the City of Portland in the 90th Legislature.

And be it further resolved that a certified copy of these resolutions be forwarded by the Clerk to His Excellency the Governor, the Secretary of State and the City Clerk of the City of Portland.

Thereupon, the House accepted the Report of the Committee, and on motion by Mr. Shesong of Portland, it was voted that the Resolu-

tion be adopted.
