Orders of the Day

Mr. FARWELL of Unity: Mr. Speaker, I move that the House reconsider its action whereby on Thursday, January 16th, it referred to the Committee on Ways and Bridges House Paper 203, Resolve in Favor of the City of Belfast, presented by the gentleman from Stockton Springs, Mr. Worth.

In explanation of this I would say that Mr. Worth is confined to his home at the present time and is unable to attend this session. The SPEAKER: The gentleman from Unity, Mr. Farwell, moves that

The SPEAKER: The gentleman from Unity, Mr. Farwell, moves that the House reconsider its action taken on Thursday, January 16th, whereby Resolve in Favor of the City of Belfast, H. P. 203, was referred to the Committee on Ways and Bridges. Is this the pleasure of the House?

The motion prevailed; and on further motion by the same gentleman, the Resolve was tabled pending reference to a committee.

Mr. Macdonald of Belfast, was granted unanimous consent to address the House.

Mr. MACDONALD: Mr. Speaker and Members of the Ninetieth Legislature: I have asked for and have geen graciously granted an opportunity to put before you my understanding of the question on my eligibility to keep my seat in this House. I will make this statement as briefly as possible, but should I appear to digress a little off the main issue I ask your forbearance as I think it all ties together.

I lived for over thirty years in South Africa. During the years 1931 and 1932 I met there the lady who is now my wife and who is an American citizen. We got engaged, and, as I had no special ties to keep me there—I have only one daughter there and she is married and settled down with her family—it was decided that I should sell my rather extensive interests there and come over to this country to settle down. This I did, and I applied for my immigration quota which was granted. This corroborates my intention to become an American citizen at the earliest possible date.

I arrived in this country early in 1933, was married the following day, and two days later came to Belfast to take up permanent residence. Within two weeks after getting there I applied for my citizen-ship papers. I realize now that I should have put those papers papers through the Clerk of Courts as he was more conversant with the regulations and procedure to be adopt-ed. Actually, I put the matter through another legal channel, with the result that I was put through in the longest possible way. I do not blame this official, as I understand that the regulations of the Immigration Department have been so amended and altered in recent years that anyone who is not intimately concerned with them has a hard job to get at the facts.

The law reads that an alien marrying an American citizen is not required to take out first papers. He may immediately apply for his final papers and these papers are granted within three years. I submit that if this procedure had been adopted as it should have been there would be no question of this issue arising today. I submit that I can reasonably contend, and I do so contend, that my residential qualifications under the law are sufficient to make my eligibility for office to retain this seat unquestioned. I complied with the law all the way through; I did all that it was my duty to do to become a citizen at the earliest possible date and it was not my fault that these papers were not put through in time.

I might say in conclusion that I did not volunteer to become a nember of this House; I was asked to by a number of prominent Re-publicans in Belfast. All during the election period this question was never raised, either in the primaries or in the primary election. It was only after the September election that the rumor got around, but no official intimation was made to me. for a ruling, but he seemed loath to give it, and, as precipitated action on my part might have involved the City of Belfast in the expense of a new election, I accepted the advice of my friends and sat back. I have acted throughout in good faith, and the vast majority of the citizens of Belfast, both Republi-can and Democrat, do not wish to see any alteration in the present status quo. (Applause)
