HOUSE

Wednesday, January 29, 1941.

The House met according to adjournment and was called to order by the Speaker.

To the Honorable Senate and House of Representatives of the Ninetieth Legislature:

We are in receipt of order dated January 22, 1941, H. P. 383 requesting the Department of Audit to report to the 90th Legislature regarding the cost of administration of the provisions of Chapter 216, Public Laws of 1937.

Chapter 216, Public Laws of 1937 requires that every town, city and plantation of the State of Maine shall have an annual audit by the Department of Audit or by a Public Accountant qualified by the State Auditor for the purpose. During the year 1940, approxi-

During the year 1940, approximately one half the municipalities were audited by State Department of Audit and the balance by Public Accountants; while about the same proportion held in the two previous years subsequent to the passage of the law above referred to. It is evident that those audits handled by outside Public Accountants were not a factor of "cost" to the State of Maine of administration of the provisions of this Chapter.

Of the audits handled by our department, we find that lack of detailed records in our office previous to last spring make it impossible to clearly determine the cost to the State of these audits, since that work is combined with and handled coincident to, but without separate records, audits of the State's own departments, and those of Counties, Normal Schools, Port of Portland Authority, etc. In a general way my investigation of last spring indicated that the charges made to the towns by the State for the work almost exactly offset the cost of the same to the State, including overhead expense of the Municipal Division of the Department of Audit, such as salaries, office supplies, typists, etc.

In the three fiscal years between July 1, 1937 and June 30, 1940. our records indicate that the Depart-ment of Audit actually received \$53,-762.76 for audit work on the books of various municipalities; while during the same period, the accounts receivable increased \$1,538.63, largely or entirely from work on town books: the two together totalling \$55,301.39 considered as total receipts during the three years from municipal work. During the same period, the total expenditures of the de-partment of Audit equalled \$125,-044.70; any breakdown of which into costs of audits of municipalities, state departments, counties, etc. is at this date impractical because of lack of primary data. In general, investigations by the State Auditor last spring, coupled with the out-come given below for the six months period. July 1 to December 1, 1940, indicates the probability that the cost of municipal work varied very little from the amount received therefrom in the same period, shown above to have been \$55,301.39; resulting in little if any "Cost of administration of the provisions of Chapter 216 of Public Laws of 1937" for those three years. The breakdown by years follows:

Beginning July 1, 1940 accurate gures on these various matters figures on have been kept in our office. A careful analysis of figures for the six months from July 1, to December 31, 1940 indicates the total cost of work under Chapter 216, Public Laws of 1937, to have been approximately \$13,363.32, and that during the same time charges were made against various municipalities for work done in that six months in the sum of \$13,513.77, leaving a total excess of income over expense. or a gain to the State of Maine, of \$150.45, from theoperations under the above mentioned chapter. Since the above cost did not include any share of the salary of the State Auditor and certain general overhead of the De-partment of Audit. it could be argued that \$150.45 was a minimum portion of the same to be borne by municipal audits under the Chapter above mentioned and that therefore there was no "Cost of administration of the provisions of Chapter 216, Public Laws of 1937" in the last six months; the only one for which we have figures available. It may be mentioned that there was no provision in the figures from our department furnished to the Budget Officer for the current fiscal year or for the two succeeding fiscal years for any net cost for municipal audits; they having been informed that the cost of these would be approximately offset by billings and that the same would be without net expense to the State.

Committee Amendment "A" to H. P. 18, L. D. 13, Bill "An Act Relating to Duties of Overseers of the Poor."

Further amend said Bill by strik-ing out the word "person" in the fifth line thereof and inserting in the place thereof the word 'persons.'

I asked him to go down with me yesterday while I checked up to see what time it would take and if it was worth the effort, and he was courteous enough to do that. He feels now the information he requires is of sufficient importance so he wants the work done, and no one could object to that.

But I suggest on these Orders calling for work from an administhese Orders trative department that you consider well what you are doing when you put them in, and perhaps check up a little bit in advance and see if the information you want is worth the trouble you are causing. If so, by all means put them in.
