## HOUSE

Thursday, January 30, 1941.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Clifford of Gardiner.

Journal of the previous session read and approved.

Mr. PAYSON of Portland: Mr. Speaker, I move that the rules be suspended to allow the introduction of an Order out of order.

The SPEAKER: The gentleman from Portland, Mr. Payson, moves that the rules be suspended to permit him to introduce an Order out of order. Is this the pleasure of the House?

The motion prevailed, and the gentleman from Portland, Mr. Payson, thereupon presented the following Order and moved its passage:

ORDERED, the Senate concurring, that the Revisor of Statutes be directed to file immediately after four o'clock today, January 30th, 1941, with the Secretary of the Senate and Clerk of the House, a list of the titles of proposed Bills of a private and special nature, data for which shall be in his hands at or before 4 P. M. today, January 30th, together with the names of the prospective introducers:

AND BE IT FURTHER ORDERED, that notwithstanding Joint Orders now in effect, Bills so listed shall be received in the same manner as if received before 4 P. M. today, January 30th (H. P. 87)

Thereupon, the Order received passage, and on further motion by Mr. Payson, was sent forthwith to the Senate for concurrence.
