Mr. STARRETT: Mr. Speaker, I desire to announce the presence in the hall of the House of Representative-elect William T. Smith of Thomaston, and move you that he be conducted to the Governor and Council to take the prescribed oaths to qualify him to enter upon his duties as a member of this House.

ing Mr. FENLASON of Anson: Mr Speaker, the statute provides that our two Indian tribes may be represented in the Legislature and that their representatives shall be paid two hundred dollars a year and their expenses. This Resolve provides that that amount be reduced to one hundred dollars. What that is for, I do not know. I have heard no recommendation for a cut in salaries from anyone.

Most of the members know bow our government acquired title to this vast land of ours. I see no reason why we should attack a tribe powerless to vote. This body is here to protect them and this body

Now I do not want to influence the opinion of any member of this House, but I do not want it said that I jumped on the Indians, and, for that reason I am going to move for the indefinite postponement of the Resolve

The SPEAKER: The gentleman from Anson, Mr. Fenlason, moves the indefinite postponement of the

Resolve

The Chair recognizes the gentleman from Auburn, Mr. Jacobs. Mr. JACOBS: Mr. Speaker, in

answer to the gentleman who has just spoken (Mr. Fenlason) in regard to this particular item, I will say that the committee felt that we were not attacking the Indian

tribes of our State but simply reducing the amount of money paid to the representative.

He comes here to this Legislature representing his tribe. He has no voice in our body; he has no vote whatsoever. We felt that this is perhaps only a recognition of a certain faction of our State citizenry, and that for one month, coming here to represent his constituency, the Indians of Old Town, that it was ample for him to have four weeks' vacation with pay and fare paid on the railroad.

We are not attacking the Indians as a whole; we are just attacking the salary of the representative. For what we get out of it, we felt that one hundred dollars was am-

ple for the service rendered.

Mr. DWINAL of Camden: Mr.
Speaker, I want to say at the outset that I personally am opposed to cutting down the compensation that the Indian representatives have been getting. I should, however, like to ask of any member that can answer me what the situation will be if this Resolve is indefinitely postponed. Would we then be in the position of the Indian representative receiving anything at all?

Mr. MURCHIE of Calais: Mr. Speaker, I hesitate to inject myself into this first Indian War of the Ninetieth Legislature. I do not, on the other hand, want to be accused of being a slacker, and, while I may not have been one hundred per cent for this cut, I felt that I should go with that committee who absolutely sincere in what along were

they felt they were trying to do.

If you will permit me, Mr.

Speaker, I would like to be seated and ask the member from Bangor, Miss Clough, to make a little speech. The member from Bangor, Miss Clough, is a part of my program. (Applause)

Miss CLOUGH of Bangor: Speaker, as there are certain rules that govern our debate, I would ask to suspend those rules that I may address the House by unanimous

consent briefly.

The SPEAKER: The Chair rule that the member has the floor on this Resolve and has a right to address the House on the motion of the gentleman from North Anson, Mr. Fenlason, that the Resolve be indefinitely postponed.

Miss CLOUGH: Thank you, Mr.

Mr. Speaker and Members of the

Recognizing an ancient and honorable custom which members of one tribe get together with another tribe for very significant ceremony, the smoking of the peace pipe, I now move that House Rule 25 be suspended to permit smoking throughout the remainder of this morning's session. Mr. MURCHIE (Continuing): Mr. Speaker, there appear to be just two ways that this matter might be settled. It will probably be settled by a vote of this House, and I am by a vote of this flows, and I am sure we will all agree with whatever that happens to be.

There is another way it might be settled, and that is by the member and the settled and the settle

from Anson (Mr. Fenlason) and myself to be permitted to fight it out with gloves down in the rostrum. He is a great big fellow and stands over the top of my head, and I probably would be getting some punishment. (Laughter)

Now I am going to try to be serious. I am sure that the members of my committee were sincere, and, inasmuch as it makes very little difference to the members of this House or to the State of Maine, I will leave it to the members of this

House to decide.

Mr. McGLAUFLIN of Portland: Mr. Speaker, if I understand correctly, it has been the custom of this Legislature to award to the Indian representative the sum of two hundred dollars. Two years ago

we had considerable agitation to try to increase the salary rather than to decrease it. We had considerable discussion upon that matter. Some of us felt that it was a good gesture for us to have an Indian occupy a seat in this House although he could not vote and although he took no part in the deliberations.

I, for one, believe that the sum of two hundred dollars for the expense of the Indian to allow him to come here if he sees fit is little enough, and I would be in favor of increasing the amount rather than decreasing it as proposed by the Committee. I therefore am in favor of the motion of the gentleman from Anson, Mr. Fenlason, to indefinitely postpone this resolve for one hundred dollars.

Mr. SLEEPER of Rockland: Mr. Speaker and Members of the House: I, too, hesitate to take part in this debate because it is-well I don't

know just what. We had a similar Bill two years ago that was introduced to increase the pay of the Indian members, and the present presiding officer of this body and several others took it upon themselves to find out the whys and wherefores in regard to the Indian members.

There is no statute that says the Indian members shall sit in this House; there is no statute that says they shall be given a certain amount

of money.

At the first inaugural in 1820 a few Indian tribes were invited to attend, and they did, fifteen of them, and they were each presented with a new blanket and sent home. The custom gathered momentum from that occasion, and at almost all inaugurals for fifty or sixty years the Indians sent their chiefs or head men down and they sat at the right or the left of the rostrum when the Governor was inaugurated.

During the Civil War, the custom was established of paying them their railroad fares back and forth, but there never has been any mention of giving them a stated amount, and there never has been any statute that says they shall sit here as members of this Legislature. They are allowed to sit in that extra seat which is nominally the Speaker's seat if he wishes to use it. That seat does not belong to the Indian member. Seat 141 is for the Speaker any time he wishes to sit on the floor of the House.

The whole thing is just a matter

of custom. If this House feels they can afford to throw away one hun-If this House feels they dred dollars or two hundred dollars, that is up to the House. One hundred dollars still looks pretty large to me. Up until the gay twenties, at the time when everyone in this country felt so rich, the Indian members used to be paid their fare and twenty-five dollars. enough to buy a new suit or a new blanket as the case might be. But during the twenties, when everyone felt prosperous. the Indians were granted at one session two hundred dollars, and

The members of the Appropriations Committee, trying to save a few dollars, felt that one hundred dollars was enough for that Indian member to come down here and stay two or three days, with his fare paid, and go back home. We still think one hundred dollars is enough. It is up to you members of the Legislature. I do not believe your political foundations will rise or fall on the fate of this measure. If you feel you can throw away one hundred dollars, vote for the motion of the gentleman from Anson, Mr. Fenlason; but if you feel one hundred dollars is worth saving, vote for the Resolve as is.

Mr. FENLASON: Mr. Speaker, in reply to the gentleman, I will say I should expect we could save a great deal more than one hundred dollars if we wanted to cut salaries. The gentleman has stated that the seat over there does not belong to the Indians. I am not so sure that the whole State does not belong to the Indians.

Now I have heard demands or suggestions for increases in salaries while I have been here of people who never asked for it, yet here is a great holler about saving one hundred dollars and cheating one of these poor redskins out of it. Before you take a vote here to hog-tie a group of men who have no vote and who can do nothing about it, I would like to have you hesitate and ask yourselves this question: "What would Jesus do were He in your place?"

The SPEAKER: The question is on the motion of the gentleman from Anson, Mr. Fenlason, that the Resolve in favor of Horace Polchies. Representative of the Penobscot Tribe of Indians (H. P. 869) (L. D. 2021) he indefinitely postnoped. Is 302) be indefinitely postponed. Is the House ready for the question? As many as are in favor of the

indefinite postponement of the Resolve will say aye; those opposed no. A viva voce vote being doubted, a

division was had.

Sixty-one having voted in the af-firmative and 56 in the negative, the motion prevailed, and the Re-solve was indefinitely postponed and

sent up for concurrence.

Mr. FENLASON: Mr. Speaker—
