Approximate Amount of Pollution From Sewage and Mill Waste Carried by the Androscoggin River

The pollution load of the Andro-scoggin River from sewage is estimated to be the equivalent of 50 gallons per capita daily and calculations are made on the basis of the population figures from the 1930 census. Industrial wastes are estimated as gallons per day with supplemental information relating to certain waste products which are lost or discarded and carried away

The industrial wastes are estimated for the industrial plants starting at Rumford and ending at Lisbon Falls. Information available includes the following wastes for each working day.

The above includes in addition to a miscellaneous group of wastes, the composition of which could not be ascertained, the following ingredients—240 pounds of spent dyes, 100 pounds of soap, 1,900 pounds of salt, 2,500 cubic feet of organic matter from meat-packing plants, the weight of which could not be obtained, 12,300 pounds of ground wood fiber, and 4,800 pounds of clay.

The minimum flow of the river near Auburn, during the period of observation, was 510 cubic feet per second, which is the equivalent of nearly 330,000,000 gallons per day (329,621,670). The average daily flow for the month of August. when the conditions were at their worst, was 2,410 cubic feet per second, or 1,-557,623,970 gallons per day. At the time in October when conditions had materially improved, the flow was somewhat less, averaging 2,245 cubic feet per second, or the equivalent of 1,450,981,665 gallons. The dilution factor for the month

The dilution factor for the month of August, at the time of investigation, for the 63,957,630 gallons of sewage and industrial wastes would be on the basis of 1 part of waste to 24.3 parts of river water, providing that all the wastes were emptied into the river at one point where the flow was measured. However, the dilution factor for all the wastes entering the river above Lewiston and Auburn is only 1 part of waste to 55 parts of river water, calculated on the average flow for the month of August. It should be observed that the flow of the river as measured includes the waste in the various establishments and returned again to the river with the added increments of waste materials produced by all the activities of the community.

It may likewise be observed that during the year 1937 a very serious condition developed comparable to ihat of August, 1940, and was the source of many complaints similar to those of the past year. Because of this fact, tables have been prepared so that the flow of the river in that year can be compared with the flow during 1940.
