Friday, February 28, 1941.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Dunn of

Gardiner.

Journal of the previous session read and approved.

From the Senate: The following

Order:

ORDERED, the House concurring, that the state highway commission be and hereby is authorized and directed to expend not to exceed \$25,000 from the highway maintenance fund, Appropriation 9055, for matching federal funds for the construction of defense highways with the provision that the main-tenance fund shall be reimbursed from the general highway fund, Appropriation 9010, within the present fiscal year (S. P. 474)

Mr. FARWELL: Mr. Speaker, I
believe at this time that it is necessary to give a brief explanation of

this order.

There is available to the State of Maine through the Federal government a great deal of money for highway purposes. By appropriating \$25,000, it will enable the State of Maine to receive from the Federal government \$660,000, which will be expended upon the State Highway systems of the State of Maine on nine projects which have been laid out by the State Highway Commission. This money will be expended under the supervision of and by the State Highway Commission of the State of Maine. It is necessary that we do this by an order for the reason that these funds must be made available almost immediately or we will not be able to take advantage of this proposition.

Later on, the sum of about three millions of dollars will be made available and, by appropriating this twenty-five thousand dollars immediately, that will enable us later on to take advantage of a larger sum of money which the Federal government will be giving to us.

This bill has been carefully considered by your Committee on Ways

and Bridges, passed out unan-imously, and it has the approval of the Maine Municipal Association and, I understand, also of the present administration here in the State House. By appropriating this small sum of money and receiving from the Federal government \$660,-000, it would seem to me that this is wisdom on the part of the State, and I hope that you may support the committee in their "Ought to pass" report.

Mr. GOULD: Mr. Speaker, this seems to me altogether too good to be true. I cannot understand how we can expend \$25,000 and expect to receive \$660,000 in return. I hope that we will get something further for an explanation than we already have.

Mr. FARWELL: Mr. Speaker, in answer to the gentleman's question: This money is made available to the State of Maine under WPA projects. Mr. Fitzgerald has assured our Governor and has assured us that if we will put in \$25,000 the total expenditure will be \$660,000, employing one thousand men im-The projects have almediately. ready been laid out and will be under construction this week.

It does seem too good to be true; but, if you will stop to think, under these WPA projects it is not unusual for the Federal government to give such a sum of money for such a small outlay. We have the assurance of the Federal government, if we may take it, that this is absolutely a fact and will be started immediately. started immediately.
