HOUSE

Tuesday, March 18, 1941.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Hughes of Augusta.

Journal of the previous session read and approved.

Petition from the Senate requiring reference disposed of in concurrence.

Orders of the Day

On motion of Mr. Payson of Portland, the House voted to take from the table the eighth tabled and unassigned matter, House Report "Ought not to pass" of the Committee on Claims on Resolve in Favor of Watts Detective Agency, Inc. (H. P. 229) (L. D. 75), which report was accepted in the House on February 26th and in the Senate was recommitted to the Committee on Claims in non-concurrence, tabled by that gentleman on March 14th, pending further consideration.

The SPEAKER: The Chair recognizes the gentleman from Perham,

Mr. Bragdon.

Mr. BRAGDON: Mr. Speaker and Members of the House: I understand that the Claims Committee has no objection to having this matter recommitted, and I would move that we recede from our former action whereby the House accepted the committee report "Ought not to pass" and concur with the Senate in recommitting this matter to the Committee on Claims.

The SPEAKER: The gentleman from Perham, Mr. Bragdon, moves, under suspension of the rules, that the House recede from its action whereby it accepted the "Ought not to pass" report of the committee and concur with the Senate in the recommitment of this report and bill to the Committee on Claims. The motion prevailed, and the bill and report were recommitted to the Committee on Claims in concur-

rence.

On motion by Mr. Grua of Livermore Falls, the House voted to take from the table the fifth tabled and unassigned matter, Bill "An Act Amending the Law relating to Unemployment Compensation with respect to Keeping Separate Accounts" (H. P. 1256) (L. D. 555) tabled by that gentleman on March 13th, pending passage to be enacted.

On motion by the gentleman from Calais, Mr. Murchie, the House voted to suspend the rules, to permit that gentleman to move to reconsider the passage of this bill to be engrossed; and on further motion by the same gentleman the House voted to reconsider its action whereby this bill was passed to be engrossed on March 6th.

Mr. Murchie thereupon presented House Amendment "A" and moved its adoption.

House Amendment "A" to H. P. 1256, L. D. 555, Bill "An Act Amending the Law relating to Unemployment Compensation with respect to Keeping Separate Accounts."

Amend said bill by drawing a line through the figures "\$25,000" in the 14th line thereof, and inserting after said figures the following: 'not more than \$20,000'

House Amendment "A" was then adopted and the bill was passed to be engrossed as amended in non-concurrence and sent up for concurrence.

On motion by Mr. LaFleur of Portland, the House voted to take from the table the twelfth tabled and unassigned matter. Committee Amendment "A" to H. P. 1484, L. D. 613, Bill "An Act to Exempt Soldiers and Sailors from Poll Taxes" tabled by that gentleman on March 14th, pending adoption.

On further motion by the same gentleman, Committee Amendment "A" was indefinitely postponed.

The same gentleman thereupon offered House Amendment "A" and moved its adoption.

House Amendment "A" to H. P. 1484, L. D. 613, Bill, "An Act to Exempt Soldiers and Sailors from Poll Taxes."

Amend said bill by striking out all of said Bill after the enacting clause, and inserting in place thereof the following:

"R. S., c. 13, § 6, ¶ IX-A, additional. Section 6 of chapter 13 of the revised statutes is hereby amended by adding thereto a new paragraph to be numbered IX-A, and to read as follows:

TX-A. The polls of persons, for each municipal year in which a poll tax is assessed during which the person liable for such poll is for a period of 6 months a member of the armed forces of the United States of America'."

The bill and amendment were thereupon tabled to permit reproduction of House Amendment "A" under the Joint Rules.
