#### SENATE

Thursday, January 23, 1941.

The Senate was called to order by the President.

Frayer by the Reverend W. W. Fowle of Hallowell.

Journal of yesterday read and approved.

#### Orders

#### (Out of Order)

On motion by Mr. Friend of Somerset, out of order and under suspension of the rules, it was

ORDERED, the House concurring that when the Senate and House adjourn, they adjourn to meet on Tuesday, January 28, 1941, at tenthirty o'clock in the forenoon. (S. P. 132)

Sent down for concurrence.

Subsequently the foregoing order was returned from the House, having been read and passed in concurrence.

#### Joint Order

(Out of Order)

Mr. Friend of Somerset presented the following order:

CRDERED, the House concurring that the State Highway Commission be authorized to expend not to exceed eight thousand dollars from the General Highway Fund for completing the traffic flow maps undertaken by the statewide highway planning survey and for the compilation of data collected by the planning survey necessary to establish a secondary federal aid highway system in accordance with the requirements of the United States Public Roads administration.

Mr. FRIEND: Mr. President, I believe that this order appropriating eight thousand dollars from the General Highway Fund requires a brief explanation.

In the summer of 1937 the Highway Planning Survey started and continued until the summer of 1939, last summer, when it was discontinued because of lack of funds. In that two year period vast amounts of figures and material were gathered together but the funds for doing this work ran out at just the wrong time. These facts and materials gathered have never been organized together and compiled into

usable form This eight thousand dollars in this order would make it possible to use at least some of these facts and figures and compile them and organize them together into a form that could be used. This work would be completed before the adjournment of this legislature and therefore would be of use to the legislature, and would be completed in time for the Highway Department to use in an intelligent manner in determining its secondary federal highway program its state highway program and its maintenance program for the summer this year.

That is the reason for presenting the order so that the work can begin tomorrow. If this work went through the ordinary channels of the highway law the money would not be available and therefore the work would not start until at least April 15 or May 1. Therefore the result of the work would not be available or advantageous either to the legislature or to the Highway Department this year. The Federal Bureau of Public Roads is very anxious that this appropriation made, the Highway Department is strongly in favor of it and our Governor believes that it is absolutely essential because it will help Highway Department very materially in arriving at the determination of a proper secondary and state highway construction program and maintenance program for the coming year.

I would consider the passage of this order very wise and good business on the part of the state of Maine and, Mr. President and members of the Senate, I urge its passage.
