Wednesday, February 19, 1941.

The Senate was called to order by the President.

Prayer by the Reverend J. C. Rice of Hallowell.

Journal of vesterday read and approved.

Papers from the House referred in concurrence.

House Committee Reports Recommitted

The Committee on Inland Fisheries and Game on "Resolve Regulating Fishing in Damariscotta Lake," (H. P. 240) (L. D. 79) re-ported that the same ought to pass.

On motion of Mr. Brown of Aroostook, the Senate voted to take from the table Joint Order Requesting the Commissioner of Health and Welfare to Furnish Old Age Assistance Lists" (H. P. 1504) tabled by that Senator on February 18 pending passage in concurrence and to-day assigned.

Thereupon, the same Senator presented Senate Amendment A and moved its adoption:

"Senate Amendment A to H. P. 1504 entitled "Joint Order Requesting the Commissioner of Health and Welfare to Furnish Old Age Assistance Lists".

Amend said Order by striking out all of said Order after the paragraph numbered 3 thereof, and inserting in place thereof the following:

'AND BE IT FURTHER ORDER-ED, that this information be furnished by the filing of a copy of the required data with the Clerk of the House, and a copy with the Secretary of the Senate, for the purpose of permitting members of the Legislature, only, to review the allocation of Old Age Assistance allotments.
