In compliance with the Order of February 11, 1941 of the Ninetieth Legislature (H. P. 1503), directing the Department of Health and Welfare to furnish the names and residences of all persons receiving pensions from the State, by towns and counties, we submit the following statement:

There is attached hereto and made a part hereof a document entitled "Retirement Pensions as of December 31, 1940." This list of Retirement Pensions includes those former State employees paid through this Department on the through this Department on the

basis of Council Orders.

The Department has available and is ready to submit, if so desired, an additional list of names arranged by towns and counties of the Veterans of the Civil War,

Spanish War, and Philippine Inspanish war, and Finispine Insurrection, and their Dependents, granted under the provisions of Chapter 116 of the Public Laws of 1935. Chapter 116 of the Public Laws of 1935 refers to grants made under that chapter as "pensions" however, the body of the act itself specificially provides that the money is given only on the basis of need. The Department is, thereneed. fore, uncertain as to whether the Legislature desires to receive and publish the information concerning these Veterans and will await further information from you concerning this.

All of the above information relates to persons receiving pensions from the State through the Depart-ment of Health and Welfare. This Department is not informed as to what other people what other people are receiving pensions from the State through

other State departments.
