Wednesday, March 12, 1941.

Senate called to order by President.

Prayer by the Rev. A. T. Mc-Whorter of Augusta.

Journal of yesterday read and approved.

From the House:

The Committee on Mercantile Affairs and Insurance on Bill "An Act Relating to Payment of the Special Tax for Investigation of Fires by the Insurance Commission-(H. P. 1273) (L. D. 543) reported that the same ought to pass.

of Maine:

I have the honor to transmit herewith a petition of Louis B. Lausier of Biddeford and others to initiate a bill entitled "An Act to Provide a Police Commission for the City of Biddeford."

This bill is initiated in accordance with Section 18 of Chapter XXXI of the Constitution of Maine and is proposed by what is purported to be not less than 12,000 electors, namely, 12,402, as shown by the signatures on the petitions accompanying this communication, which were filed in the office of the Secretary of State on March 8, 1941.

There is also transmitted herewith additional petitions in reference to the same bill purporting to be signed by 251 electors, which were filed on March 10, 1941.

There has been no check in this office as to the sufficiency of the signatures on said petitions.

Upon motion by Mr. Chamberlain of Penobscot, the Senate voted to take from the table, bill, An Act Limiting the Amount of Inventory of the State Liquor Commission (H. P. 611) (L.
