ORDERED, the Senate concur-ring, that the State Controller shall file as soon as possible with the Speaker of the House a report of all salary adjustments approved by the Personnel Board and passed by the Governor and Council within the period from January 21, 1941 to January 14, 1942. Amendment "A" submitted herewith: Committee Amendment "A" to Senate Paper 578, Legislative Document 1196, bill, "An Act Regulating Fishing and Hunting Licenses of Soldiers and Sailors. Amend said bill by adding thereto the fol-lowing: "Section 3. Complimentary Licenses May be Issued. The Gov-ernor is hereby authorized in his discretion to issue complimentary fishing and hunting licenses to members of the Canadian Immigration and Custom forces who serve in such capacity on the Maine border.

Which report was read and accepted, and the bill read once; Committee Amendment "A" was was read and adopted, and the bill as amended next Monday afternoon at four o'clock assigned for second reading.

it was ORDERED, the House concurring, that Belmont Smith and the Maine Bonding and Casualty Company be and hereby are released from liability on a certain bond payable to the State of Maine, bearing date July 1, 1941, and being numbered 52834, in so far as said bond covered the faithful discharge by the said Belmont Smith of all the duties and obligations of the office of Treasurer of the State of Maine from and after midnight of July 6, 1941, and, be it further

ORDERED, that a certain bond executed by Belmont Smith and the Peerless Casualty Company payable to the State of Maine written for the penal sum of \$75,000.00, bearing date July 7, 1941, being numbered F16153, which bond pro-vides for the faithful discharge by said Belmont Smith of all the duties and obligations of the office of Treasurer of the State of Maine as required by law is hereby approved.
