# SENATE

# Wednesday, January 27, 1943.

The Senate was called to order by the President

Prayer by the Rev. Father Wil-liam Tudor Bulkeley of Hallowell. Journal of yesterday read and ap-

proved.

Papers from the House referred in concurrence.

# Order

On motion by Mr. Bragdon of Aroostook, it was

ORDERED, that there be printed 750 copies each of (S. P. 61) "An Act to Improve the Efficiency of the Administration of the Liquor Laws and to Safeguard State Revenues During the Present Emer-gency;" (S. P. 62) "An Act Relat-ing to the Regulation of the Sale of Malt Liquors to Minors"; (S. P. 63) "An Act Relating to Enforce-ment of the Liquor Laws;" (S. P. 64) "An Act to Regulate the Sale of Wines Produced by Natural Fermentation or Fortified."

#### Orders of the Day

On motion by Mr. Brown of Aroostook, the Senate voted to take from the table, Joint Order relative to discontinuing Special Road Re-solves (H. P. 3) tabled by that Senator on January 13 pending passage in concurrence.

Mr. BROWN of Aroostook: Mr. President, I now move the indefinite postponement of this order in non-In support of concurrence. that motion, I wish to make a few brief remarks. In the first place I hesitate to raise this point in view of the many learned members of the Bar we have here, but I wish to say first that I believe that this order is unconstitutional. It is true that the legislature may pass anything it wishes regarding the con-duct of its own business. If this special type of legislation were barred it would deny to the people their right to introduce through their representatives into the legislature such legislation as they may want.

Secondly, I think it is very poor legislative practice to pass an order forbidding the introduction of legislation whether it is constitutional or not.

Thirdly, it is faultily drawn because there is no such thing as a special resolve and even if we passed this order any member could continue to introduce resolves.

And fourthly, I want to say that at a meeting of the Committee on Ways and Bridges yesterday, a joint committee made up of members of both the House and Senate unanimously asked me to take this order from the table and move its indefinite postponement in non-concur-rence. Therefore, Mr. President, I make that motion.

Mr. DORR of Oxford: Mr. President, I would like to second the motion of the Senator from Aroostook, Senator Brown.

Thereupon, the order was indefinitely postponed in non-concurrence.

Mr. BROWN: Mr. President, in order to expedite matters and because I think they are waiting for this paper in order to determine what to do, I move that this order be sent forthwith to the House.

The motion prevailed.

On motion by Mr. Sanborn of Cumberland, the Senate voted to take from the table bill An Act in Relation to Fees of Referees (S. P. 121) tabled by that Senator on January 21 pending reference; on further motion by the same Senator, the bill was referred to the Committee on Salaries and Fees and ordered printed. Sent down for concurrence.

Mr. ELLIOT of Knox: Mr. President, with the explanation that the Governor will deliver his budget message this afternoon, I move that the Senate do now recess until this afternoon at 4:30 o'clock. The motion to recess prevailed.

#### After Recess

The Senate was called to order by the President.

#### Order

Out of order and under suspension of the rules on motion by Mr. Friend of Somerset, it was ORDERED, that a message be sent to the House of Representa-

tives proposing a convention of both branches of the Legislature to be held forthwith in the Hall of the House for the purpose of extending to his Excellency, the Governor, an invitation to attend the Convention and make such communication as pleases him.

The Secretary delivered the message and subsequently reported that he had performed the duty assigned to him.

Subsequently a message was received from the House by Mr. Pease, its Clerk, concurring in the proposition for a joint convention for the purpose of extending an invitation to his Excellency, the Governor, to attend the Convention and make such communication as he may be pleased to make.

On motion by Mr. Bishop of Sagadahoc, the Senate voted to take from the table bill, An Act Relating to Annual Audit of Municipalities (S. P. 99) tabled by that Senator on January 20 pending reference; on further motion by the same Senator, the bill was referred to the Committee on Towns.

Sent down for concurrence.

Thereupon the Senate retired to the Hall of the House of Representatives where a Joint Convention formed.
