#### Orders of the Day

Mr. BROWN of Aroostook: Mr. President, I would like to ask if Senate Paper 154 An Act Forbidding the Planting of Chippewa Potatoes is in the possession of the Senate?
The PRESIDENT: It is. Mr. BROWN: Mr. President, I would like now to ask leave to withdraw this bill and a brief explanation as to the reasons, both for the introduction and the withdrawal might be in order.

I will say that I introduced this bill at the request of a very large and successful farmer, a former member of this Senate, George He requested me to in-Findlen. troduce the bill for the reason that Chippewa potatoes are claimed by a great many people to be a spreader of potato disease and, as I said, at his request I introduced the bill. now have a letter from Mr. Findlen asking me to withdraw the bill, which I will read:—

"Dear Ι George: believe should withdraw the Chippewa bill that I asked you to introduce, for the following reasons.

"A great many people up here still want to grow Chippewas and feel that we are infringing on their rights when we outlaw that variety. There are some people in the county who can grow good Chippewas and they want the privilege.

"I believe I am right in trying to have Chippewas outlawed but I don't believe I could have any real support at a hearing. I wouldn't want to ask Arostook people to come to a hearing that was one-sided. For these reasons I am asking you to withdraw the bill."
Mr. President, I ask leave to withdraw the bill.

Leave to withdraw was granted. Sent down for concurrence.
