SENATE

Wednesday, February 17, 1943 The Senate was called to order by the President.

Orders of the Day Order

Out of order and under suspension of the rules, on motion by Mr. Elliot of Knox, it was ORDERED that the members of

the Men's Club of the Penney Memorial Church be granted the use of the Senate Chamber on the evening of February 25, 1943 for the purpose of listening to an address by the Hon. Clifford E. McGlauflin of Portland.

On motion by Mr. Batchelder of York, the Senate voted to take from the table bill "An Act Relating to the Building and Maintenance of Highway Crossings of Railroads," (S. P. 148) (L. D. 148) tabled by that senator on February 12 pending acceptance of the report; and on further motion by the same senator, the report was accepted and the bill was given its first reading and tomorrow assigned for second reading.

On motion by Mr. McGlauflin of Cumberland, the Senate voted to take from the table "Resolve Proposing an Amendment to the Constitution to Limit to Highway Purposes the Use of Revenues Derived from the Taxation of Vehicles Used on the P blic Highways, and Fuels Used for Propulsion of such Vehicles," (S. P. 233) tabled by that senator on February 4 pending motion to refer to the Committee on Ways and Bridges.

Mr. McGLAUFLIN of Cumber-land: Mr. President, as I stated to the Senate yesterday, this is a measure that should be referred to a legal committee because it re-lates to a fundamental law of the state. The Committee on Reference must be well aware of that fact, and the only explanation for it going to Ways and Bridges that I can conceive, is that some influential member of the legislature has requested such reference. I have no quarrel with the members of the Ways and Bridges Committee. It is made up of good men and they are all friends of mine so far as that is concerned, but I would venture to say that not half of the members of the legislature even know the requirements of the constitution itself for making amendment to that constitution. You would not select a farmer to make out your income tax, and you would not select a carpenter to make out your will. This is a mat-ter that requires careful and impartial consideration.

The object of having this go to a Ways and Bridges committee is obviously with the hope that a committee which knows nothing about constitutional law is more likely to act favorably on the bill than one

that is acting impartially for the welfare of the whole state. And the reason would apparently be that because it indirectly relates to roads, perhaps this committee would be more favorable. Now this matter stands at the present moment this way: There is a motion before this Senate to refer this to the Ways and Bridges committee. When that motion is put by the President, if the Senate votes No, then I would make a motion to have this Resolve referred to the Committee on Legal Affairs.

Mr. FRIEND of Somerset: Mr. President, I regret very much that I find it necessary to oppose the Senator from Cumberland, Senator McGlauflin in this matter, but I really think that the recommendation of the Committee on Reference of Bills should be sustained. I really think that this is very definitely a highways and bridges matter. It deals with all the highways and bridges money, all of the money raised by the gas tax and registrations, amounting ordinarily to some ten millions of dollars a year, and so far as I know in past legislatures such bills as this have always been referred to the Committee on Ways and Bridges.

I very much hope that the Senate will see fit to so refer this Resselve and I hope that the motion of the Senator from Knox, Senator Elliot, to refer this Resolve to the Committee on Ways and Bridges

will prevail.

Mr. McGLAUFLIN: Mr. President, when the vote is taken, I ask for a division of the Senate.

Mr. BISHOP of Sagadahoc: Mr. President, just to clarify the record with reference to the remarks made by the Senator from Cumberland, Senator McGlauflin, I would like to state that I am a farmer and that the people in my community have come to me to get help in making out their income tax rates.

Mr. BROWN of Aroostook: Mr. President, I had not intended to take part in this controversy, being a member of the Committee on Ways and Bridges, and it is immaterial to me which committee it comes before. If it comes before the Committee on Legal Affairs, there will be one less headache for the members of the Committee on Ways and Bridges.

However, I resent the implication of the Senator from Cumberland (Senator McGlauflin) that the members of the Committee on Ways

and Bridges are not qualified to properly act on this measure.

Some of the members of the Committee on Ways and Bridges have served on that committee for several years and we as members of that committee have the recommendation of the allotting of ten or twelve million dollars a year. Some of us have made quite a study of the set-up of ways and bridges and how the money is spent. It is true that we may not know all the ramifications necessary to amend the Constitution but most of us understand that it first has to be passed by the legislature by a majority votand then it goes to the people to enact. I think we understand that part of it.

As far as not going to farmers to make out income taxes I would like to say, gentlemen, that all like to say, gentlemen, that all farmers do not have to go to lawyers to make out their income taxes because I have made out my own ever since they were required and

I have never had my returns questioned.

I think the proper reference for this resolve is to the Committee on Ways and Bridges the same as any other matter dealing strictly with

ways and bridges.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Knox, Senator Elliot, that this Resolve, Senate Paper 233, be referred to the Com-mittee on Ways and Bridges. Is the Senate ready for the question? The Senator from Cumberland, Senator McGlauflin has asked for a division.

A division of the Senate was had. Twenty-four having voted in the affirmative and three opposed, the motion to refer the Resolve to the Committee on Ways and Bridges prevailed.
