# SENATE

Thursday, February 25, 1943 Then Senate was called to order by the President.

Prayer by the Reverend J. C. Rice, of Hallowell.

Journal of yesterday read and approved.

From the House:

Mr. BISHOP of Sagadahoc presented

Bill "An Act Creating a State Board of Eugenics." (S. P. 424)

(The Committee on Reference of Bills suggests that this bill be referred to the Committee on Judiciary.)

Mr. BISHOP of Sagadahoc: Mr. President, I wish at this time to make a few brief remarks concerning this measure. You, and many of the members of this Body of two years ago, will remember the origin and the history of this bill. That is now ancient history.

I came to this session of the legislature thoroughly convinced and fully determined that, in view of the world-wide unrest, it would be out of order and inexpedient to consider this matter at this session and this year. I did, however, feel that, being a member of several legislative committees that have to do with the visiting of institutions which would be affected by this bill, it was proper and in order to preserve and protect the title and the contents.

That I did by filing with the Revisor of Statutes the present title and the bill, still fully determined that this was not the proper time to consider the bill further, yet, not knowing what might be presented from our visits to these institutions, it seemed proper to protect the bill.

I would like to tell you at this time some of the facts that the visiting committee have found in their visits to the three institutions, the Bangor State Hospital, the Augusta State Hospital and the Pownal State School for Feeble-Minded. I take time to tell you these facts because I deplore the fact that so many of our legislative committees that visit these various state institutions take a day or two to visit these places at the expense of the state, partake of a bountiful dinner, smoke their cigars and cigarettes, go home and never bring back any information of what they find.

At Bangor we found 1155 patients herded or crowded into quarters that were designed for 600 patients; and being cared for by attendants 40 or 50 less in number than should, and ought, to be provided to care for these people, being paid salaries from three dollars up to fifteen and eighteen dollars a week. The total annual cost of the Bangor State Hospital, aside from the investment and overhead, is \$374,500.

Over across the river, at the Augusta State Hospital, we found over 1500 patients with 70 less employees

than are needed to carry on the worl; there. In one ward in particular we found 96 bed-ridden, insane patients unable to care for themselves. They have to be fed as you would feed a baby. They have to be bathed every day. There was one nurse and two inexperienced girls for their attendants in that one particular ward, changing over 400 sheets a day; and we expect any sort of efficiency from such a set-up. The total cost of the Augusta State Hospital is \$462,000 annually

Over at Pownal we found 1120 patients with the same conditions in regard to personnel and help, but far different conditions in regard to the inmates. At the two insane hospitals the people who were at one time able, efficient, and very highly intelligent people who (because of complicated surroundings or accidents or perhaps inherited weakness or alcoholism, or whatnot) have become deranged and mentally sick.

At the Bangor State Hospital, Dr. Hedin stated that the commitments due to alcoholism have increased from six to eight percent since the repeal of prohibition. Some 22 percent of their commitments are due to alcoholism.

It is a little different over here in Augusta; but over at Pownal, we found deplorable and horrible conditions which would be affected by the measures in this bill that we are considering. 20 percent of those 1120are high-grade patients morons, meaning that they have the intelligence of seven to twelve years, with a full grown body but an un-developed mind. Forty percent of the inmates at Pownal are lowgrade morons, meaning mentality from three to seven years; and the other forty percent are made up of idiots, poor, unfortunate, distressed people born to parents who are likewise idiots.

We found one family there of six children, all in the low-grade bracket, their mother and father still at large, still reproducing and still supplying material for the institution. We saw some of the most horrible sights that any person could imagine.

Now I believe that the other members of this body who have been members of that committee; namely, the Senator from Cumberland, Senator Sanborn; the Senator from Cumberland, Senator Hanold; the Senator from Somerset, Senator Sterling; the Senator from Androscoggin, Senator Boucher; will verify my statements. After less than an hour, or an hour or two, Senator Hanold asked leave to be excused. He had seen enough!

I am so concerned about this, and about humanity in general, that I would stake everything that I own in the world if it were possible to provide means for you folks and for every member of this legislature, to visit the Pownal State School.

If that could be and if others, who would oppose such a measure as this bill, could and would go there, openmindedly, not afraid of outside pressure groups, and not concerned with re-election, I believe that, to the last man, this group, or any other group, would favor such a measure. But that is beside the point, and I am still convinced and determined that this is not the proper or opportune time to ask action on this bill.

However, these are the conditions nat exist. The Pownal State that \$368,000 School costs annually. They have 400 on the active waiting list, and experts claim that for every one who is housed at this institution or other institutions like it-at the institutions they are being well cared for - but for every one who is housed there there are nine at large in our communities. You know who they are. You see them in your cities and town, one or two here and there, a small percentage perhaps, but they do exist, and constitute a social problem.

My bill was designed to protect the general public, socially and economically; in some way to curb the reproduction of these people who are unfortunate, who are mentally deficient, who always have been, and who always will be. They reproduce twice as fast as ordinary families. They are never self-supporting. They never can be. They are social mis-fits, ostracised by society.

Now, this is a social problem as well as an economic problem. Some day someone is going to have the courage to face the facts. In this country two years ago it cost a hundred and seventy-three millions of dollars to maintain institutions just like Pownal. Those costs have increased something over ten percent, making it more than two hundred millions of dollars annually at the present time. And that takes care of only ten percent of the mentally deficient persons. The other ninety percent are still at large.

I present these facts and this information for your benefit, for your consideration. I believe it is important. I wanted this to go on the record. In the next two years, or in the future, I plan, hope and ex-pect to keep talking about this thing and to continue my study of it. I have taken a little more time

than I had planned, perhaps, Mr. President, but I wanted this information presented. I think it should be. I wanted to report to some group, somewhere, somehow, the results of our visits to these institutions. I believe that if we are to function we should warrant our existence and the cost of our visits to these places.

We go, come back, and do nothing, or little or nothing about it. As Chairman of the committees on which I serve, and as a member of the other visiting committee-the Indian Affairs Committee-I have asked and insisted at the hearings and at the executive sessions that each member appear before whatever committee or whatever group is necessary and tell the story of the findings as they have seen them, whether it is before the Appropriations Committee or wherever it is. I believe it is our duty to go there and give a picture of the things that we find. Otherwise our existence is not warranted.

Now, Mr. President, with these remarks concluded, I ask leave to withdraw the bill.

Thereupon, leave was granted to the Senator from Sagadahoc, Senator Bishop, to withdraw the bill.
