Wednesday, January 3, 1945.

In convention of the memberselect of the Ninety-second Legis-

lature.

This day being the day designated by the Constitution of the State for the meeting of the Ninety-second Legislature, the members-elect of the House of Representatives assembled in the hall of the House of Representatives at ten o'clock A. M. and were called to order by Harvey R. Pease, Clerk of the House of 1943.

Prayer was then offered by the Rev. Dr. William R. Wood of

Augusta,

A communication was received from the Secretary of State transmitting a certified roll of the Representatives-elect of the Ninetysecond Legislature, which was read by the Clerk.

On motion by Mr. Ward of Millinocket, the communication

ordered placed on file.

A certified roll of Representatives-elect was then called by the Clerk of the Ninety-first Legislature. The elected membership of the House being 151, 147 members-elect having answered to their names, a quorum was found to be present.

Those who were absent were:

Messrs. Anderson of Oxbow Bl., Cole of Casco, Gross of Jefferson and Martin of Eagle Lake.
On motion by Mr. Ward of Millinocket, that gentleman and Miss Deering of Bath, and Messrs. Jacobs of Auburn, Perkins of Boothbay Harbor, Williams of Clifton and Haskell of Portland were appointed a committee to wait upon the Governor and inform him that a quorum of the members-elect of the House of Representatives had assembled in the hall of the House and to request his attendance to administer to them the oaths re-guired by the Constitution to qualify them to enter upon the discharge of their official duties.

Mr. Ward subsequently reported that the committee had discharged the duty assigned it, and that the Governor was pleased to say that he would forthwith attend upon the Representatives-elect for the purpose of administering to them the oaths required by the Con-

stitution.

The report of the committee was accepted.

Thereupon, the Governor, tended by his Council, and escorted by the Honorable Harold I. Goss, Secretary of State, entered the hall amid applause of the House, the members rising, and administered to the members-elect, and they subscribed the oaths required by the Constitution to qualify them to discharge their official duties.

Governor Sewall then addressed

the House as follows

GOVERNOR SEWALL: Members of the 92nd. Legislature: In looking over the Legislative Record, I find that this is an occasion—or has been in the past—when Governors have made rather extended remarks. have made rather extended remarks. Frankly, I feel no such urge at this time. I do want you to know, however, that I am very happy to welcome you all here to the State House at the beginning of this session. I want each of you who, in the next were in this House in the past, were in this House while I have been down in the corner office, to realize how much I appreciate everything you have done to help me as I was trying to work out our common problems.

I feel that the past is on the

record and that the future is in very competent hands; so I wish you a very successful session, and I feel absolutely confident that whatever the problems will be that they will be successfully and wisely worked out for the people of Maine by you and by the next Governor.

(Applause, members rising.)
Governor Sewall, attended by his Council and escorted by the Honorable Harold I. Goss, then retired. amid the applause of the House,

the members rising.

On motion by Mr. Bowker of gentleman Portland, that and Messrs. Smith of Newport, Gay of Damariscotta, Berry of Livermore Falls, Haskell of Bangor, Weeks of Waterville and Morrison of Rumford, were appointed a committee to receive, sort and count votes for Speaker of the House.

On motion by Mr. Boutin of Lewiston, it was voted that the committee cast one ballot for George B. Barnes as Speaker of the House of Representatives of the Ninetysecond Legislature.

The motion prevailed, and the Chairman of the committee cast one ballot for George B. Barnes, as Speaker of the House, and that gentleman was declared duly elected Speaker of the House of Representatives of the Ninety-second Legislature.

Speaker Barnes was then escorted to the rostrum by the gentleman from Lewiston, Mr. Boutin, where he assumed the Chair, amid the applause of the House, the members rising.

The SPEAKER: Members of the House of the Ninety-second Legis-islature: You have this morning placed upon me grave responsibility: you have also placed me irretrievably in your debt, and I want you to know that I am deeply ap-

to know that I am preciative of the honor.

It could never be trite to remind you that these are serious times through which we are going. The work of this Legislature in this session should have as its goal proper legislation to take care of your boys, brothers and cousins who are fight-ing on the far-flung battlefronts. No one knows—and of course we can not—when this conflict will be over; but it should be our obligation to be ready for it. Within a few days, the committees will be named for this Legislature, and then the responsibility of the work will be on your shoulders. I know that this will be a united House, and I know that we will have a successful session. I want to take occasion again to thank you ladies and gentlemen who have conferred upon me this honor. (Applause)

The SPEAKER: The Chair awaits the pleasure of the House.

On motion by Mr. Cousins of Old Town, that gentleman and Messrs. Lombard of Yarmouth, Jones of Waterville, Cole of Casco, Thompson of Brewer, Meloon of Portland and Jennings of Strong, were appointed a committee to receive, sort and count votes for Clerk of the House.

On motion by Mr. Boutin of Lewiston, it was voted that the Committee cast one ballot for Harvey R. Pease of Wiscasset, as Clerk of the House of Representatives of the

Ninety-second Legislature.

The motion prevailed, and the Chairman of the Committee cast one ballet for Harvey R. Pease, of Wiscasset, as Clerk of the House and that gentleman was declared duly elected as Clerk of the House of the Ninety-second Legislature. (Applause)

On motion by Mr. Forhan of Canton, that gentleman and Mr. Brewer of Presque Isle, Mrs. Lord of South Portland, and Messrs. Harrison of Portland, Heanssler of Deer Isle, Morse of Oakland and Mrs. Ellingwood of Rockland, were appointed a committee to receive, sort and count votes for Assistant Clerk of the House.

On motion by Mr. Donahue of Biddeford, it was voted that the Chairman of the Committee cast one ballot for Roy S. Humphrey as Assistant Clerk of the House.

The motion prevailed and the Chairman of the Committee cast one ballot for Roy S. Humphrey of Augusta, as Assistant Clerk of the House, and that gentleman was declared duly elected Assistant Clerk of the House of the Ninety-second Legislature. (Applause)

On motion by Mr. Crosby of Farmington, that gentleman and Messrs. Warren of Westbrook, Leathers of Hermon, Hawes of Vassalboro, Poulin of Rumford, Black of Dexter, and Burton of Orneville were appointed a committee to notify the Governor of the organization of the House by the election of Honorable George B. Barnes as Speaker, Harvey R. Pease as Clerk and Roy S. Humphrey as Assistant Clerk.

Mr. Crosby subsequently reported that the committee had discharged

the duty assigned it.

The same information was conveyed to the Senate by Mr. Ward of Millinocket.

At this time a message was received from the Senate, through Senator Spear of Cumberland, informing the House that the Senate had been duly organized by the election of Honorable George D. Varney of York, as President, Royden V. Brown as Secretary and Chester T. Winslow as Assistant Secretary.

On motion by Mr. Williams of Clifton, that gentleman conducted the Clerk and Assistant Clerk to the Governor to take and subscribe the oaths necessary to qualify them to enter upon the discharge of their official duties, and Mr. Williams subsequently reported that he had discharged the duty assigned him, and that the Clerk and Assistant Clerk had taken and subscribed the oaths required by the Constitution to qualify them to enter upon the discharge of their official duties.

Thereupon, Harvey R. Pease, Clerk, and Roy S. Humphrey, Assistant Clerk, appeared and entered upon the discharge of their official duties.

On motion by Mr. Boutin of Lewiston, it was

ORDERED, that Frank H. Tre-orgy of Surry, be Sergeant-atworgy of Surry, be Sergeant-at-Arms; J. Warren Butman of Readfield, be Assistant Sergeant-at-Arms; James E. Harvey of Read-field, be Document Clerk; Elmer Abbott of Augusta, be Doorkeeper; and that Alan C. Pease of Wiscas-set, and Gloria Belin of Monmouth, be the Pages.

The following communication: STATE OF MAINE OFFICE OF THE SECRETARY OF STATE

The communication with accompanying papers was received, and on motion by Mr. Ward of Millinocket, tabled pending reference to a committee.

On motion by Mr. Ward of Millinocket, it was

ORDERED, that Ruel C. Hanks of Augusta, be the Official Reporter of the House for the present session: and that he be authorized to procure the services of a typist and proof-reader during the present session for the preparation and completion of the Legislative Record.

On motion by Miss Deering of Bath, it was

ORDERED, that the Clerk of the House be directed to maintain in his office an alphabetical index of all matters before the Legislature, and a legislative docket showing all action taken on all matters before the Legislature; the necessary additional clerical assistance to be employed by the Clerk with the approval of the Speaker.

On motion by Mr. Rankin of Bridgton, it was

ORDERED, that the Clerk of the House be directed to invite the Clergymen of Augusta, Hallowell and Gardiner to officiate as Chaplains of the House during the present session.

On motion by Mr. Ward of Millinocket, it was

ORDERED, that the Speaker be authorized to appoint a Secretary to the Speaker and that the Clerk be authorized to appoint a Secretary to the Clerk, a Legislative Docket Clerk and an Assistant Legislative Docket Clerk.

On motion by Miss Deering of Bath, it was

ORDERED, that the rules of the House of Representatives of the Ninety-first Legislature be adopted for the government of this House until otherwise ordered.

The SPEAKER: The Chair recog-

nizes the gentleman from Milli-nocket, Mr. Ward. Mr. WARD: Mr. Speaker, in or-der to expedite the business of the remainder of today's session, I ask unanimous consent that the order of business as provided in the rules just adopted be dispensed with and that the House proceed under Orders of the Day.

The SPEAKER: The gentleman from Millinocket, Mr. Ward, asks that by unanimous consent the unanimous consent the order of business as provided by the rules just adopted be dispensed with today, and that the House proceed under Orders of the Day. The Chair hears no objection and unanimous consent is hereby granted. Fromnow on, in today's session, all matters of business will be out of order and under suspension of the rules.

The Chair would call the attention of the members of the House to one of the rules that the House has just adopted, which is Rule 25, which the Chair will read: "Smok-ing is prohibited in the hall of the House of Representatives while the House is in session.

On motion by Mr. Ward of Millinocket, out of order and under sus-pension of the rules, it was

ORDERED, that each adjournment of the House be until 10 o'clock of the following morning unless otherwise ordered.

Mr. Brewer of Presque Isle, was granted unanimous consent to ad-

dress the House. Mr. BREWER: Mr. Speaker and Mr. Brewer: Mr. Speaker and Members of the 92nd Legislature: As you will notice by the paper which you will find on your desk, through a clerical error, the provision establishing the April trial term of Superior Court in Aroosterle Country of Superior Court in Aroosterle Country of Superior Court in Chapter took County as enacted by Chapter 138 of the Public Laws of 1943, was omitted from the new revision. In order to prevent confusion and misunderstanding, it is necessary to correct this error immediately by emergency legislation. I think that this, in itself, is self-explanatory, and at this time I present a bill and move its passage.

The SPEAKER: Out of order, the gentleman from Presque Isle, Mr. Brewer, presents a bill and asks unanimous consent that at this time it be accepted and that it be given its three several readings and passed to be engrossed, without reference to a committee. Is this the pleasure

of the House?

The motion prevailed, and Bill "An Act Relating to Trial Terms of the Superior Court in Aroostook County" (H. P. 1) was received out of order and under suspension of

the rules.

Thereupon, the bill was given its three several readings under suspension of the rules and passed to be engrossed without reference to a committee; and on motion by Mr. Brewer, the bill was ordered sent forthwith to the Senate.

Out of order and under suspension of the rules, Miss Deering of Bath, presented the following Order

and moved its passage:
ORDERED, that the members of the House proceed with the drawing of seats; that the usual monitors' seats be assigned to the monitors appointed by the Speaker; that a choice of seats be granted to Floor Leaders and Assistant Floor Leaders of the majority and minority parties; that a choice of seats be granted to the lady members of the House and other members with physical disabilities.

The Chair at The SPEAKER: this time, before the vote on this Order, will read House Rule 6: "One monitor shall be appointed by the Speaker for each division of the House, whose duty shall be to see to the observance of the rules of the House, and on demand of the Speaker, to return the number of votes and members in his division.

As this time the Chair will make the appointment of monitors: For Division Number One, the gentle-man from Portland, Mr. Bowker; for Division Number Two, the gentleman from North Anson, Mr. Ela; Division Number Three, the gentleman from Clifton, Mr. Williams; and for Division Number Four, the gentleman from Portland, Mr. Haskell.

At this time, also, the Floor Leaders and Assistant Floor Leaders will take their choice of seats, and the members with physical impairments and the lady members of the House will also take their choice of seats.

Thereupon, the Order received passage, and the House proceeded

with the drawing of seats.

A message was then received from the Senate, through its Secretary, proposing a Joint Convention of both branches of the Legislature. to be held at 2:30 o'clock this afternoon for the purpose of electing a Secretary of State, Treasurer of State, Attorney General, State Auditor, Commissioner of Agriculture and the seven Executive Councillors.

On motion by Mr. Ward of Millinocket, the House voted to concur with the Senate in the proposition for a Joint Convention, and the Clerk was charged with and conveyed a message to the Senate. informing that body that the House concurred in the proposition for a Joint Convention.

The Clerk subsequently reported that he had discharged the duty assigned him.

1946.

On motion by Senator Sterling of

Somerset, it was

ORDERED, that the Secretary be directed to notify the Honorable Harold I. Goss of his election as Secretary of State: Honorable Jo-seph H. McGillicuddy of his elec-tion as Treasurer of State: Honorable Ralph W. Farris of his election as Attorney General; Honor-able Fred M. Berry of his election as State Auditor; Honorable Carl R. Smith of his election as Commissioner of Agriculture; and the Honorables George J. Wentworth, Harold N. Hanold, Lincoln M. Clement, Earl Fenlason, James L. Woodbury, Harold W. Worthen and Clarence B. Beckett, of their elections as Executive Councillors for the years 1945 and 1946.

Subsequently the Secretary reported that he had notified the of-
