ORDERED, That Rule 47 of the Rules of the House be amended by striking out the time "4 o'clock" in the second sentence, and inserting in place thereof the time '1 o'clock', so that the second sentence shall read as follows: "All such petitions, memorials, papers, bills and resolves, which are deposited in said box before one o'clock in the afternoon of each day shall be removed therefrom by the Clerk, and shall be introduced and received in the House on the following day, at which time they shall be presented to the House by the Speaker or such other person as the Speaker may request, and referred to the proper committees, unless the House shall otherwise order."

Mr. WARD: Mr. Speaker and Members of the House: Under our present rules, the little box here is opened up at four o'clock every afternoon and the bills and resolves go to the Committee on Reference of Bills, and after they have completed their work they then go into the Clerk's office where the next day's journal and calendar are prepared. There are a number of days when the volume of bills makes it necessary for them to work quite a few hours to prepare that calendar and journal, and, consequently, it is late when the printer gets it for printing.

If we adopt this change, it simply means that instead of opening the box every afternoon at four o'clock it will be opened at one o'clock and the bills immediately considered by the Committee on Reference of Bills, and then the force in the Clerk's office can go to work on them and get the calendar to the printer much earlier. This would not affect the closure rule in any way and would simply facilitate the work of the House.

I ask unanimous consent that the order be considered immediately.
