Report of the Committee on Judiciary reporting "Ought not to pass" on Resolve Proposing a Constitutional Amendment Changing the Times of Meetings of the Legislaure (S. P. 30)

The SPEAKER: The Chair recognizes the gentleman from Greenville, Mr. Rollins.

Mr. ROLLINS: Mr. Speaker, this bill proposing a change in the meetings of the Legislature was heard down in the Judiciary Committee day before yesterday. After due consideration, it immediately came out on the calendar in the Senate the next morning "Ought not to pass."

I just want to mention here that the House has just concurred with the Senate in passing an order to extend the time for introduction of

bills.

Some members have said to me that everyone in the State of Maine knows that the Legislature convenes on the first Wednesday of January and that they should prepare their bills and have them ready. We all know that everybody knows, or should know, that the automobile licenses are due on the first of March; but all of us who have ever witnessed the throngs that are in the street at all the automobile license places, realize that, after all, perhaps the people of Maine are not so well-informed

are not so well-informed.

I would like to say at this time that I have heard a lot of criticism.

and I have been spoken to this morning in regard to how this bill was going. Now this bill is reported out "Ought not to pass," and they do not plan on giving it any consideration. But each member sitting here realizes that, for the benefits fit of better legislation and for publicity on the bills that are going to be put before this Legislature, that something like the split-session idea some day will be the answer.

For the information of the members present who do not know it, let me say that we have put in a month here in this Legislature, and the exact time that has been spent in the House is ten hours, twentyone minutes and a half-and a half of that time was used up in conassembling and assembling, in receiving the mes-sages of our Honorable Governor, the Inauguration Message and the Budget Message.

I just wanted to impress upon the members that this bill, which was reported out "Ought not to pass" immediately, is exactly the thing that we are trying to get around by the order to extend the time for the introduction of bills.

Mr. SPEAKER, I now move that this "Ought not to pass" report of the Committee be accepted. The SPEAKER: The gentleman

from Greenville, Mr. Rollins, moves that the House accept the "Ought not to pass' report of the committee. Is this the pleasure of the House?
