# Ought to Pass with Committee Amendment

Report of the Committee Judiciary on Bill "An Act Authorizing the Withholding of the Federal Income Tax" (S. P. 31) (L. D. 329) reporting "Ought to pass" as amended by Committee Amendment "A" submitted therewith.

Committee Amendment "A" to S. P. 31 (L. D. 329), Bill "An Act Authorizing the Withholding of the

Federal Income Tax."

Amend said bill by inserting after the title and before the enacting clause thereof the following:

'Emergency preamble.

Whereas, in order to cooperate with the federal government in the collection of income taxes it is necessary to provide for the withhelling of a certain per cent of the salaries and wages of all state, county and municipal officials and employees; and

Whereas, any delay in setting up the mechanics for withholding said income taxes would work a hardship on said state, county and municipal officials and employees, and the

state; and

Whereas, in the judgment of the legislature these facts create an emergency within the meaning of section 16 of Article XXXI of the constitution of Mains and require constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety now, therefore.

Further amend said bill by adding at the end thereof the following:

'Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.
