They may also appoint an inspector of buildings, an inspector of electric wiring, equipment, and appliances, and such clerks and assistants to these officials as they deem necessary, prescribe their duties, set their compensation subject to the approval of the board of finance, and terminate their employment at be the barrier and their employment at pleasure. They may designate any member of the department as de-fined in the 1st sentence of this section to perform any of the duties provided for in the 2nd sentence, and any member so designated shall lose none of his rights as a member of the department.
