Tuesday, February 27, 1945. The House met according to adjournment and was called to order

by the Speaker. Prayer by the Rev. L. L. Dunn of Belgrade.

Orders of the Day

Canton, Forhan of Mr. was granted unanimous consent to address the House.

Mr. FORHAN: Mr. Speaker and Members of the House: I have a resolve in regard to a pension for a Mrs. Edith Cole, of West Paris. I received a letter from Mrs. Cole last week, February 19th, which was the first time I had anything to do with this pension. She claimed at that time that she had written previously to have a resolve introduced in regular form. I went to the Department of Health and Welfare and learned there that Mrs. Cole was granted a pension of \$12 a month six years ago.

This woman is bed-ridden and has been for twenty-nine years; her husband is able to work only part of the time. She now asks for an increase, and I have had a resolve drafted, and, by unanimous consent, I would like permission to introduce it at this time.

The SPEAKER: The gentleman om Canton, Mr. Forhan, asks from unanimous consent to introduce a resolve. Is there objection? The Chair hears no objection, and the resolve is received. The Clerk will read the title.

"Resolve Providing for a State Pension for Edith M. Cole, of West Paris." (H. P. 1313) On motion by Mr. Forhan, the

resolve was referred to the Committee on Pensions and sent up for concurrence.

Mr. Rollins of Greenville, was granted unanimous consent to address the House.

Mr. ROLLINS: Mr. Speaker and Members of the House: Through a misunderstanding on somebody's part between myself and the Re-visor of Statutes, in printing the bills to be received, I had three bills introduced covering the same subject: The item introduced this morning, "Resolve in favor of town of Greenville to Correct Height of Overpass of the Canadian Pacific Railroad at Greenville Junction," and the eighteenth unassigned matter which was tabled by me on the last legislative day, Resolve per-mitting Fox & Ginn, Inc., to Sue the State of Maine, and also there was supposed to be a bill for a claim which Fox & Ginn has paid in connection with passing around this overpass in the performance of their hugings because the currents their business, because the overpass is too low.

I tabled this bill the last legislative day, pending reference, be-cause I would have liked to have seen the bill go to the Committee on Claims. If the bill is paid and the Committee on Claims allows the just bill, then I would ask leave to withdraw the resolve permitting the right to sue.

Therefore, at this time, in order to correct this error and to perform justice, I would ask unanimous con-

sent to introduce a resolve. The SPEAKER: The gentleman from Greenville, Mr. Rollins, asks unanimous consent to introduce a resolve. Is there objection? The Chair hears none and the resolve is received. The Clerk will read the title.

Resolve in Favor of Fox & Ginn. (H. P. 1314)

On motion by Mr. Rollins, the resolve was referred to the Committee on Claims and sent up for concurrence.

On motion by Mr. Carpenter of Augusta, the House voted to take from the table the seventeenth tabled and unassigned matter, Bill "An Act Relating to Sellers and Weighers of Coal and Coke" (H. P. 829) (L. D. 434) tabled on February 23rd by that gentleman, pending third reading; and on further motion by the same gentleman, the bill was given its third reading, passed to be engrossed and sent up for concurrence.

On motion by Mr. Rollins of Greenville, the House voted to take from the table the fifth tabled and unassigned matter, House Report "Ought to pass" with Committee Amendment "A" of the Committee on Taxation on Bill "An Act Relating to the Assessment and Collection of State, County and Forestry District Taxes in Unorganized Territory" (H. P. 446) (L. D. 173) tabled on February 20th by that gentleman pending acceptance of report; and on further motion by the same gentleman, the report of the committee was accepted. This being a printed bill under suspension of the rules the bill was read twice.

Committee Amendment "A" was read by the Clerk as follows:

Committee Amendment "A" to H. P. 446, L. D. 173, Bill, "An Act Relating to the Assessment and Collection of State, County and Forestry District Taxes in the Unorganized Territory."

Amend said Bill by adding thereto a new section to be numbered "Sec. 3-A." and to read as follows:

"Sec. 3-A. R. S., c. 14, § 73-A, additional. Chapter 14 of the revised statutes is hereby amended by adding thereto a new section to be numbered 73-A to read as follows:

'Sec. 73-A. Certification to treasurer of state and state controller. Before commencing to collect the taxes which the state ta_x assessor is authorized by law to collect, he shall certify to the treasurer of state and the state controller the total amount of each type of tax. Copies of all supplemental assessments and abatements of taxes shall also be sent to the treasurer of state.'

Further amend said Bill by deleting in Section 9 thereof the underlined words "through the provisions of section 79" in the 9th line of the bill (8th and 9th lines of the bill as printed).

Further amend Section 9 thereof by deleting the underlined word "He" in the 23rd line (21st line of the bill as printed) and substituting in place thereof the underlined words "The state tax assessor."

Further amend said bill by deleting in Section 10 thereof the word "and" after the word "collection" in the 5th line thereof and substituting in place thereof a comma (4th line of bill as printed).

Further amend Section 10 by inserting the words 'and disposition of the proceeds of such tax sales' after the words "tax sales" in the 5th line of the bill (4th line of bill as printed).

Committee Amendment "A" was adopted.

Mr. Rollins thereupon offered House Amendment "A" and moved its adoption.

House Amendment "A" read by the Clerk as follows:

House Amendment "A" to H. P. 446, L. D. 173, Bill "An Act Relating to the Assessment and Collection of State, County and Forestry District Taxes in the Unorganized Territory".

Amend said Bill in the 29th and 30th lines of section 9 of said bill (lines 28 and 29 of section 9 of the bill as printed) by deleting the underlined words "unless otherwise directed by the legislature" and substituting in place thereof the underlined words 'of sales, except sales to the former owners of the lands'.

the former owners of the lands'. House Amendment "A" was adopted, and the bill was assigned for third reading tomorrow morning.
