Wednesday, July 10, 1946.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Reidel of Augusta.

Journal of the previous session read and approved.

The SPEAKER: The Chair rules on that, and, in so ruling, the Chair will quote the Governor's Message, and also part of the bill.

The Governor, in his message, said: "I believe that we should con-sider the question of rent control at this session because of the critical

mergency which has arisen." The bill, in Section 1, reads as follows: "All persons, partnerships, associations, and corporations doing business as wholesalers, jobbers or retailers are hereby prohibited from demanding or receiving for commodities and services in excess of that paid, charged or fixed therefor by the Office of Price Administration on June 30, 1946." Under the broad term "and ser-

vices" the Chair rules that this bill comes within the purview of the Governor's Message.

Thereupon, H. P. 1504, H. P. 1505 and H. P. 1506, were referred to the Committee on Judiciary, 1500 copies of each ordered printed and were sent up for concurrence.

Orders of the Day

Mr. Peirce of Augusta, was grant-ed unanimous consent to address the House

Mr. PEIRCE: Mr. Speaker and Members of the House: I am asking your unanimous consent to intro-duce a bill for your consideration which, if enacted, would bring a new industry to our state in the immed-iate future. This bill is timely and iate future. This bill is timely and appropriate. I believe, because this new industry would at once com-mence to employ two hundred workers, the majority of whom would be Maine veterans.

In addition to the veterans' employment angle, this company would benefit the State by making an initial property investment of initial property investment of around \$150,000. No tax exemption is requested.

The business in which the com-pany will deal is the final processing and bottling of domestic wines.

Our present liquor statute provides for the licensing of manufacturers of hard liquor, wine, and beer situated in this State. However, it is not clear that the word "manufacture" can legally be interpreted to cover the final processing and bottling which this new industry performs. The proposition can be argued both ways. Therefore, I consider this bill as being more a clarification of the present law than as an amendment to it. In view of the fact that other companies are permitted to produce completely in this State hard liquors, wines and beers, there would appear to be no reason why this Legislature should prohibit the partial processing of wines.

In order to bring a new industry to our State, to aid veterans' employment, to create a new source of tax revenue, and to clarify the existing liquor law, I am respectfully asking your unanimous consent to consider this bill.

The SPEAKER: The gentleman from Augusta, Mr. Peirce, asks unanimous consent to introduce a bill out of order. The Clerk will read the title.

(CLERK reading) Bill "An Act relating to Manufacturing and Bottling of Wine".

The SPEAKER: Does the Chair hear objection to the introduction of this bill?

Mr. PRATT of Windham: Mr. Speaker, I object.

The SPEAKER: The bill will not be received.
