Mr. Leavitt for the Committee appointed to inform the Governorelect of his election, reported that the Committee had waited upon the Honorable Horace A. The Secretary delivered the messubsequently reported sage and that he had performed the duty assigned to him.

ORDERED, the House concurring, that the Secretary of the Senate and the Clerk of the House, re-spectively, be authorized to furnish to the Superintendent of Public Disting acteur of all corrected Printing, postage on all correspond-ence relative to advertising com-mittee hearings during the present session, same to be charged to legislative expense. (S. P. 15)

Sent down for concurrence.

Subsequently the foregoing order was returned from the House, having been read and passed in concurrence.

On motion by Mr. Bishop of Sagadahoc, it was

ORDERED, that the Secretary of the Senate be directed to furnish each member and officer of the Senate during the present session with two daily newspapers printed in the State, as each member and officer may select.

On motion by Mr. TOWNSEND of Penobscot, it was

ORDERED, the House concur-ring, that the members and officers of the Legislature be furnished with express and parcel transportation for all packages and department reports in a sum not exceeding \$5.00 for each member and officer thereof. and that such transportation he furnished and expended under the direction of the Secretary of the Senate and the Clerk of the House, respectively, and the unexpended balance at the close of the year 1945 shall be available for use in 1947. (S. P. 16)

Subsequently the foregoing order was returned from the House, hav-ing been read and passed in concurrence.

On motion by Mr. SAYWARD of York, it was

ORDERED, the House concur-ring, that the Secretary of the Sen-ate and the Clerk of the House, respectively, be authorized to furnish wrappers and postage stamps for each member and officer of the Senate and House, not exceeding \$5.00 in amount each, for the purpose of distributing the various reports of the Departments of State and other public documents such as they may desire to mail to the citizens of the State. ORDERED, the House concurring, that free telephone service be provided for each member and officer of the Senate and House to the number of fifty calls, of reasonable duration, from Augusta to points within the limits of the State of Maine, and that each member and officer of the Senate and House be bonder of the Schatz and House be provided with a card to be certified to by the Secretary of the Senate and Clerk of the House, respectively, of this service to be paid to the New England Telephone and Telerates. January 3, 1945 To Honorable Royden V. Brown, Secretary of the Senate of the Ninety-second Legislature:

I hereby submit the report of the revisor of statutes as required by subsection V, section 2, chap-ter 10, of the revised statutes of 1944.

Due to the fact that the present revisor of statutes has held office only since February, 1944, and that his time has been spent largely in the completion of the revision of 1944, only limited recommendations can be made.

The suggestions made in the first report of the legislative research committee of the 91st legislature and the recommendations made by the legislative revision of statutes committee of the 91st legislature as reported in L. D. 920 of the second special session of 1944 are hereby approved and it is hoped that such suggestions and recommendations may be adopted.

There are two other matters which I would call to your attention:

1. There is at present no statutory provision for the drafting of private and special laws and of resolves, or for aid in drafting legislation for the several administrative departments. It is also sug-gested that some method be devised whereby all legislation, before be-ing brought before the legislature for consideration, should first pass through a central agency so that duplicate measures could be climi duplicate measures could be eliminated with the resulting saving of printing costs and legislative time. The entire problem of drafting legislation is so important that further study should be made by the next legislative research committee.

2. During past legislative sessions, two or more acts dealing with the same section of a particular chapter, but amending different parts of the same section, have become law. This has resulted in inconsistent rulings by our courts and in much unnecessary confusion in determining the legislative intent.

For example, chapters 72 and 205 of P. L. 1941 have created great difficulties for our courts in determining the dates set for motor vehicle inspection.

And also chapters 177 and 322 of P. L. 1943 have created confusion in interpreting the powers of municipal courts in sentencing minors

to the reformatory. The revision h has necessarily cured these two defects, but similar difficulties will undoubtedly arise in the future unless some method is devised to prevent such occurrences. An effort will be made in the office of the revisor of statutes to watch all legislation in the process of becoming law so that if possible no more than one act amending any one particular section will become law during any one legislative session. It is difficult at present to suggest any permanent method for dealing with this problem since all legislation does not go through the office of the revisor and since during any legislative session it is doubtful if time will permit close scrutiny of all bills pending before the legislature. It is suggested that this problem also be turned over to the next legislative research committee for further study.

The Chair would also state that no appointments have as yet been made for the joint select committee on the University of Maine for the same reason.
