#### SENATE

Thursday, January 18, 1945.

The Senate was called to order by the President.

Prayer by the Rev. Cleaves Henderson of Gardiner.

### Joint Order

On motion by Miss Clough of Penobscot, out of order, and under suspension of the rules, it was

ORDERED, the House concurring, that when the Senate and House adjourn, they adjourn to meet on Tuesday, January 23rd, 1945 at 4.30 o'clock in the afternoon. (S. P. 61) Sent down for concurrence.
