Mr. Currier of Androscoggin presented the following order and

ORDERED, the House concurring. that a Joint Committee be appointed immediately to investigate thoroughly and completely the fire at LaCoste Babies Home, 195 South Main Street, Auburn, occurring about 5:30 A. M. January 31, 1945, in which sixteen small children and one adult were reported to have perished.

Said Committee to supersede all other investigating committees, and to be empowered to subpoena wit-nesses and pursue any line of in-vestigation it might deem advisable to determine responsibility, if any, of this fire, and make complete report of all findings to the Legislature and to the Attorney General for any criminal prosecution that said Attorney General's department

might see fit; and be it further
ORDERED, that this committee be empowered to investigate all children's homes throughout the State, to suspend licenses of so-called homes when conditions justify such suspension, and to recom-mend detailed specifications regarding buildings, and operation of said children's homes for legislative action. All necessary expenses of this committee to be paid from the general funds of the State.

#### Committee Report

Mr. DUNBAR from the Committee on Judiciary on Bill "An Act Authorizing the Withholding of the Federal Income Tax," (S. P. 31) the reported that the same ought to pass as amended by Committee Amendment "A.

Which report was read and accepted and the Secretary read Committee Amendment A as follows:

"Committee Amendment A to S. P. 31, bill An Act Authorizing the Withholding of the Federal Income Tax.

Amend said bill by inserting after the title and before the enacting clause thereof the following:

#### Emergency preamble.

Whereas, in order to cooperate with the federal government in the collection of income taxes it is necessary to provide for the withholding of a certain per cent of the salaries and wages of all state, county and municipal officials and employees; and

Whereas, any delay in setting up the mechanics for withholding said income taxes would work a hardship on said state, county and municipal officials and employees, and

state: and

Whereas, in the judgment of the legislature these facts create an emergency within the meaning of section 16 of Article XXXI of the constitution of Maine and require the following legislation as immediately necessary for the preserva-tion of the public peace, health and safety; now, therefore,

Further amend said bill by adding at the end thereof the following:

Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when ap-
