Orders of the Day

On motion by Mr. Brown of Aroostook, the Senate voted to take from the table Joint Order Relative to Register of Bills (H. P. 1030) tabled by that Senator on February 13 pending passage in concurrence.

Mr. BROWN of Aroostook: Mr. President, at the time I tabled this Order there was considerable doubt in my mind as to the value and the cost of having these printed. I un-derstand that the indexing of bills, after all the bills are in, costs about \$400. I have had considerable expression of opinion that it is of great value to many of the members of the legislature and that they want it, and I therefore move the passage of this Order in concurrence.

Thereupon, the Order received passage in concurrence.

On motion by Mr. Noves of Hancock, the Senate voted to reconsider its former action, taken earlier in today's session whereby bill, An Act to Aid Towns in Controlling Forest Fires (S. P. 317) was referred to the Committee on Judiciary; and on further motion by the same Sen-ator, the bill was laid upon the table pending reference.

On motion by Mr. Brown of Arcostck, the Senate voted to take from the table Majority Report "Ought to pass as Amended by Committee Amendment A," Minority Report "Ought Not to Pass," from the Committee on Legal Affairs on bill, An Act Creating a Division of Community Recreation Under the State Park Commission (S. P. 50) (L. D. 13), tabled by that Senator on February 13 pending motion of the Senator from Cumberland, Senator Cleaves, that the Majority Report be accepted.

Mr. BROWN of Aroostock: Mr. President, I wish to say that in tabling this matter yesterday, I had not had time to look into it and the Senator from Cumberland (Senator Cleaves) by his glowing description of it and the far reaching powers of this bill led me to think it was something worth looking into. The PRESIDENT: The question

The PRESIDENT: The question before the Senate is on the motion of the Senator from Cumberland, Senator Cleaves, that the Majority Report "Ought to Pass as Amended by Committee Amendment A" be accepted. Is this the pleasure of the Senate?

Thereupon, the Majority Report was accepted and the bill was given its first reading.

The Secretary read Committee Amendment A:

"Committee Amendment A to S. P. 50, L. D. 13, Bill An Act Creating a Division of Community Recreation Under the State Park Commission. Amend said bill by inserting in the 4th line of that part designated 'Sec. 23-D' thereof, after the underlined word 'on', the underlined word 'community'.

"Further amend said bill by inserting in the 2nd line of sub-section I of that part designated 'Sec. 23-F" of said bill, after the underlined word 'public', the underlined word 'community'.

"Further amend said bill by inserting in the 1st line of subsection II of that part designated 'Sec. 23-F' of said bill, after the underlined word 'on' the underlined word 'comunity'.

"Further amend said bill by inserting in the 1st line of subsection V of that part designated 'Sec. 23-F' of said bill, after the underlined word 'developing', the underlined word 'community'; and by adding, before the semicolon at the end of said subsection V, the underlined words: 'in organized townships'.

"Further amend said bill by striking out all of that part of said bill designated 'Sec. 23-G', and substituting in place thereof the following 2 sections: 'Sec. 23-G. Limitation. Nothing in sections 23-A to 23-F, inclusive, shall be construed to interfere in

'Sec. 23-G. Limitation. Nothing in sections 23-A to 23-F, inclusive, shall be construed to interfere in any way with existing or future law pertaining to state parks now under the jurisdiction of the state park commission, anything in this act to the contrary notwithstanding.'

Sec. 23-H. Appropriation. There is hereby appropriated the sum of \$15,000 from the general fund to carry out the purposes of sections 23-A to 23-F, inclusive."

Committee Amendment A was adopted and the bill as so amended was tomorrow assigned for second reading.

On motion by Mr. Bishop of Sagadahoc, the Senate voted to take from the table bill An Act Relating to Teachers' Pensions (S. P. 287) tabled by that Senator on February 13 pending reference.

Mr. BISHOP of Sagadahoc: Mr. President, inasmuch as this is purely an educational matter, financed by the Department of Education and heretofore these bills have always gone to the Committee on Education, I now move that this bill be referred to the Committee on Education.

The motion to refer prevailed and the bill was ordered printed.

Sent down for concurrence.

On motion by Mr. Bishop of Sagadahoc, the Senate voted to take from the table bill, An Act to Increase Teachers' Pensions (H. P. 811) (L. D. 504) tabled by that Senator earlier in today's session pending reference to the Committee on Judiciary in concurrence; and on further motion by the same Senator the bill was referred to the Committee on Education in non-concurrence.
