SENATE

Thursday, February 15, 1945.

The Senate was called to order by

the President. Prayer by the Reverend Elmer Colcord of Gardiner.

Journal of yesterday read and approved.

Papers from the House referred in concurrence.

A viva voce vote being had The motion to accept the report in concurrence did not prevail, and the report and accompanying papers were returned to the House.

On motion by Mr. Brown of Aroostook, the Senate voted to take from the table Joint Order Relative to Investigation of the Fire at Auburn (S. P. 175) tabled by that Senator on February 1 pending passage.

Mr. BROWN of Aroostook: Mr. President, when this order was presented to create an investigating committee of the legislature with power to supersede all other investigating committees and all other investigating authorities, which would in effect supersede the office of the Attorney General which is a constitutional office, the power of the County Attorney and all the other departments of the state, I considered it was plainly out of order because we could not create by order any such power. I understand that the Senator from Androscoggin, Senator Currier, now wishes to withdraw the order and I yield to that Senator.

Mr. CURRIER of Androscoggin: Mr. President, I wish to withdraw this first tabled matter inasmuch as the phases of that Order are being covered by other legislation.

The PRESIDENT: The Senator from Androscoggin, Senator Currier, asks leave to withdraw the Order. Is there objection? The Chair hears no objection and the order is withdrawn.
