Orders of the Day

On motion by Mr. Hopkins of Kennebec, the Senate voted to take from the table House Report from the Committee on Legal Affairs

"Ought to Pass as Amended by Committee Amendment A" on bill An Act Relating to the Chief Engiher and Assistant of the City of Lewiston (H. P. 428) (L. D. 236) tabled by that Senator on February 21 pending acceptance of the re-port in concurrence; and on fur-ther motion by the same Senator the report of the committee was accepted in concurrence and the bill was given its first reading.

Thereupon, the Secretary read Committee Amendment A:

"Committee Amendment A to H. P. 428, L. D. 236, bill An Act Relating to the Chief Engineer and

Assistant of the City of Lewiston.

Amend said bill by striking out all after the enacting clause and inserting in place thereof the fol-

lowing:

P. & S. L. 1939, c. 8, Art. XII, Sec. 4 amended. Section 4 of Article XII of chapter 8 of the private and special laws of 1939, as amended by chapter 86 of the private and special laws of 1943, is hereby repealed and the following enacted in place

thereof:

'Sec. 4. 'Sec. 4. Officers; inspector of buildings; inspector of wiring. The commission may employ a chief engineer, a superintendent of fire alarm, such assistant engineers and such other officers, members and employees of the department as they deem necessary, shall direct their organization, prescribe their duties, set their compensation subject to the approval of the board of finance, and terminate their employment at pleasure; save that the chief engineer, assistant engineer and other permanent members of the department shall not be demoted nor removed unless for inefficiency or other cause detrimental to the service of the department and after hearing. They may also ap-point an inspector of buildings, an inspector of electric wiring, equipment, and appliances, and such clerks and assistants to these officials as they may deem necessary, prescribe their duties, set their compensation subject to the approval of the board of finance, and terminate their employment at pleasure. They may designate any member of the department as defined in the 1st sentence of this section to perform any of the duties provided for in the 2nd sentence, and any member so designated shall lose none of his rights as a member of the department.

The same Senator presented Senate Amendment A to Committee Amendment A.

The Secretary read the amend-

ment:

Senate Amendment "A" to Committee Amendment "A" to H. P. 428, L. D. 236, Bill, "An Act Relating to the Chief Engineer and Assistant of the City of Lewiston."

"Amend said amendment by striking out all of the 1st sentence of that part designated as 'Sec. 4.' and inserting in place thereof the

following sentence:

'The commission may employ a chief fire department engineer, a superintendent of fire alarm, such assistant fire department engineers and such other officers, members and employees of the department as they shall deem necessary, shall direct their organization, prescribe their duties, set their compensation subject to the approval of the board of finance, and terminate their employment at pleasure; save that the chief fire department engineer, assistant fire department engineer and other permanent members of the department shall not be demoted nor removed unless for inefficiency or other cause detrimental to the service of the department and after hearing.' "

Senate Amendment A to Committee Amendment A was adopted.

Committee Amendment Α amended by Senate Amendment A was adopted in non-concurrence.

Thereupon, on motion by Mr. Boucher of Androscoggin, the bill and accompanying papers were laid upon the table pending assignment for second reading.

On motion by Mr. Dow of Oxford, the Senate voted to take from the table bill An Act Extending the Workmen's Compensation Act to Cover Occupational Diseases (H. P. 1238) (L. D. 864) tabled by that Senator on February 21st pending reference in concurrence; and on further motion by the same Senator. the bill was referred to the Committee on Judiciary in concurrence.

On motion by Mr. Spear of Cumberland, the Senate voted to take from the table bill, An Act Relating to the Salary of the Commissioner of Inland Fisheries and Game (H. P. 1003) (L. D. 551) tabled by that Senator on February 14 pending reference in concurrence; and on further motion by the same Senator the bill was referred to the Committee on Salaries and Fees in concurrence.

On motion by Mr. Sterling of Somerset, the Senate voted to take from the table bill An Act Relating to White Pine Blister Rust Control (H. P. 1295) (L. D. 941) tabled by that Senator earlier in today's session pending reference in concurrence.

Mr. STERLING of Somerset: Mr. President, inasmuch as this bill is closely related to a bill that we now have before the Committee on State Lands for Forest Preservation and as we are holding the bill in com-

mittee we would like to have this bill to consider along with the other one, and I move that this bill be referred to the Committee on State Lands and Forest Preservation in non-concurrence.

The motion prevailed and the bill was referred to the Committee on State Lands and Forest Preservation in non-concurrence.
